

INVITATION TO BID FOR
Provision of General Manpower Services for May 1, 2020 to
December 31, 2020

1. The *Department of Budget and Management Regional Office VI* will be procuring a contract for *General Manpower Services* starting *May 1, 2020 to December 31, 2020*.
2. The *Department of Budget and Management Regional Office VI*, through the *FY 2020 General Appropriations Act* intends to apply the sum of *Five Hundred Ninety Five Thousand Pesos (Php 595,000.00)* being the Approved Budget for the Contract (ABC) for the contract for the *Provision of General Manpower Services for May 1, 2020 to December 31, 2020* . Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. The *Department of Budget and Management Regional Office VI* now invites bids for *Janitorial and Messengerial Services*. Delivery of the Goods is required for *May 1, 2020 to December 31, 2020*. Bidders should have completed, within *five (5) years* prior to the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations registered as a Platinum member of PhilGEPS with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
6. Interested bidders may obtain further information from *Department of Budget and Management Regional Office VI* and inspect the Bidding Documents at the address given below during *office hours*.
7. A complete set of Bidding Documents may be acquired by interested Bidders *from March 5, 2020, but not later than 11:59:59 a.m. of March 24, 2020* from the address below, *free of charge*.

8. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS).
9. Bids must be duly received by the BAC Secretariat at the address below on or before **12:00:00 p.m. of March 24, 2020**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.
10. Bid opening shall be at **1:00:00 p.m. of March 24, 2020** at **Department of Budget and Management Regional Office VI Conference Room, 251-A Gen. Hughes St., Iloilo City**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
11. The **Department of Budget and Management Regional Office VI** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
