BLACKLISTING ORDER No. 01, Series of 2024

Pursuant to Section 69 (f) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, the undersigned, hereby issues this Blacklisting Order to the entity hereafter stated:

1. SCCIP Office Supplies and Equipment Trading with Business Name No. 2464204 issued by the Department of Trade and Industry (DTI), and Philippine Government Electronic Procurement System (PhilGEPS) Registration No. 2022-032911-584862-07511 having business address at L.B.K. St., R.K. Village, Kumintang Ibaba, Batangas City, Batangas, is hereby **SUSPENDED/DISQUALIFIED** from bidding for any procurement contract with any Procuring Entity for 1 year starting from January 12, 2024 until January 11, 2025.
2. Specific ground/offense committed based on Section 4.2 of the "Uniform Guidelines for Blacklisting of Manufacturers, Suppliers, Distributors, Contractors and Consultants", *GPPB Resolution No. 40-2017, dated 21 December 2017*:
 - i. (b) Failure by the contractor to fully and faithfully comply with its contractual obligations without valid cause, or failure by the contractor to comply with any written lawful instruction of the procuring entity or its representative(s) pursuant to the implementation of the contract;
 - ii. (d) For the procurement of goods, unsatisfactory progress in the delivery of the goods by the manufacturer, supplier or distributor arising from his fault or negligence and/or unsatisfactory or inferior quality of goods, as may be provided in the contract; and
 - iii. (g) Willful or deliberate abandonment or non-performance of the project or contract by the contractor resulting in substantial breach thereof without lawful and/or just cause.
3. The penalty is being imposed in connection with the following procurement details:

- a. Name of Project: **Procurement of Tokens for PFMCP Resource Speakers and other PFM-related Sessions**
- b. Location of the Project: **Department of Budget and Management – Central Office**
- c. Approved Budget for the Contract: **P165,000.00**

The name/s of the foregoing persons and/or entities shall be posted within three (3) calendar days from the date of effectivity of this Blacklisting Order in the Consolidated Blacklisting Report (CBR) through the Online Blacklisting Portal pursuant to Section 10 of the "Uniform Guidelines for Blacklisting of Manufacturers, Suppliers, Distributors, Contractors and Consultants", *as amended by GPPB Resolution No. 14-2020 dated 25 June 2020*. The names of the Blacklisted Persons/Entity/ies shall be removed upon the lapse of the period of penalty.
