REQUEST FOR QUOTATION

The Department of Budget and Management (DBM), through its Administrative Service (AS), will undertake a Small Value Procurement for the "*Design, Fabrication and Installation of DBM Logo for DBM Buildings I and III*", General Solano St. San Miguel, Manila, in accordance with Section 53.9 of the Implementing Rules and Regulations of Republic Act No. 9184.

- Name of Project : Design, Fabrication and Installation of DBM Logo for DBM Buildings I and III
- Approved Budget for the Contract : One Hundred Sixty Thousand Pesos (P 160,000.00)
- Location : DBM Buildings I & III, Gen. Solano St., San Miguel, Manila
- Delivery Date : Thirty (30) working days from receipt of Purchase Order
- Warranty : One (1) year after acceptance by DBM of the delivered Goods on workmanship

Prospective bidders shall accomplish, provide correct and accurate information and submit the duly signed Price Quotation Form (Annex "A") together with their valid and current Mayor's Permit, DTI or SEC Registration Certificate and PhilGEPS Registration, not later than 5:00 p.m. on December 17, 2012. Open quotations may be submitted, manually or through facsimile at the Administrative Service (AS), General Services Division, G/F Mabini Hall, Malacanang, Manila with telephone nos. 735-4902/735-4921 and fax nos. 735-4979 and 735-1957.

Price quotation/s must be valid for a period of Thirty (30) calendar days from the date of submission.

Award of contract shall be made to the lowest quotation (for goods and infrastructure) or, the highest rated offer (for consulting services) which complies with the minimum technical specifications and other terms and conditions stated herein.

Any interlineations, erasures or overwriting shall be valid only if they are signed or initialed by the bidder or his/her duly authorized representative/s.

The DBM shall have the right to inspect and/or to test the goods to confirm their conformity to the technical specifications.

Liquidated damages equivalent to one tenth of one percent (0.001%) of the value of the deliverables not delivered within the prescribed period shall be imposed per day of delay. The DBM shall rescind the contract once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.

The DBM reserves the right to accept or reject any or all quotations and to impose additional terms and conditions as it may deem proper.
