## **REQUEST FOR QUOTATION**

(RFQ No. 2023-011)

#### SUPPLY AND DELIVERY OF VARIOUS FURNITURE AND FIXTURES

The Department of Budget and Management (DBM) MIMAROPA Regional Office hereinafter referred to as "Procuring Entity" (PE), through its Bids and Awards Committee (BAC), invites interested parties to submit price quotation for the Supply and Delivery of Various Furniture and Fixtures, through Negotiated Procurement - Small Value Procurement (Sec. 53.9, IRR of R.A. No. 9184) with an Approved Budget for the Contract (ABC) of **One Hundred Twenty-Two Thousand Two Hundred Eighty Pesos (P122,280.00)**.

All items listed under the PE's terms of services/ specifications must be complied with on a pass-fail basis. Failure to meet any of the requirements will result to disqualification. Likewise, it is understood that PE's terms of services/ specifications are minimum requirements. The Bidder/Service Provider may offer higher terms of services/ specifications or additional items.

Likewise, in accordance with Section 54.6 and Appendix A of Annex "H" (Consolidated Guidelines for the Alternative Methods of Procurement) of the IRR of RA 9184, the service provider shall provide the following documentary requirements, which shall be submitted together with the duly accomplished Quotation Form, as a **condition for the award** of contract:

- 1. PhilGEPS Registration Number;
- Mayor's/Business Permit (if recently expired, submit a copy of the official receipt as proof that it has applied for renewal); and
- 3. Omnibus Sworn Statement (Attachment B).

PhilGEPS Platinum Registration Certificate may be submitted in lieu of eligibility documents 1 and 2.

Your price quotation must be in Philippine Peso and must include the unit price and total price, inclusive of all taxes to be paid and other incidental costs to the delivery site if the contract is awarded.

The prospective bidder/service provider shall submit the following:

- 1. Duly accomplished Quotation Form (Attachment A);
- 2. Technical Specifications/Requirements (Attachment B); and
- 3. Brochures of the items offered, if any.

All quotations may be typewritten or handwritten and must be placed in a sealed envelope marked as "Supply and Delivery of Various Furniture and Fixtures (RFQ No. 2023-011)" and must be delivered/submitted on or before **March 10, 2023, 1:00 pm** at the DBM MIMAROPA Regional Office, 2<sup>nd</sup> Floor CSP Bldg., 815 Quezon Avenue, Brgy. Sta. Cruz, Quezon City. Late quotations shall not be accepted and considered.

**Opening of Quotations/Proposals shall be on March 10, 2023 1:30 pm** at the DBM MiMaRoPa Regional Office Conference Room, 2<sup>nd</sup> Floor CSP Bldg., 815 Quezon Avenue, Brgy. Sta. Cruz, Quezon City. Quotations shall be valid for one hundred twenty (120) calendar days from the deadline of submission of the same.

The DBM MIMAROPA Regional Office reserves the right to reject any and all quotations, and to annul the procurement process at any time prior to contract award without thereby incurring any liability to the affected bidder/service provider or bidders/service providers. The DBM MIMAROPA Regional Office also reserves the right to waive any required formality in the proposals received, and select the proposal which it deems to be most advantageous to the government.
