- 1. Bidders shall provide the correct and accurate information required in this form.
- 2. Price quotation/s must be valid for a period of *sixty (60) calendar days from* the date of submission of quotation.
- 3. Price quotation/s, to be denominated in Philippine peso shall include all taxes, duties, and/or levies payable.
- 4. Quotations exceeding the Approved Budget for the Contract shall be rejected.
- 5. Award of the contract shall be made to the lowest calculated and responsive quotation (for goods and infrastructure) or, the highest rated offer (for consulting services) which complies with the minimum technical specifications and other terms and conditions stated herein.
- 6. Any interlineations, erasures or overwriting shall be valid only if they are signed or initialed by you or any of your duly authorized representative/s.
- 7. The item/s shall be delivered according to the requirements specified in the Technical Specifications.
- 8. The DBM shall have the right to inspect and/or to test the goods to confirm their conformity to the technical specifications.
- 9. In case two or more bidders are determined to have submitted the Lowest Calculated Quotation/Lowest Calculated and Responsive Quotation, the DBM shall adopt and employ "draw lots" as the tie-breaking method to finally determine the single winning provider in accordance with GPPB Circular 06-2005.
- 10. Payment shall be processed after delivery and upon the submission of the required supporting documents, in accordance with existing government accounting rules and regulations. Please note that the corresponding bank transfer fee, if any, shall be chargeable to the contractor's account.

Procurement of Training Equipment Terms of Reference

I. BACKGROUND

As per Office Order No. 425, s. 2023, a Technical Working Group (TWG) was created, headed by Undersecretary Margaux Marie V. Salcedo, as part of the efforts of the Department to help in the devolution of functions from the National Government (NG) to the Local Government Units (LGUs), a capacity-building intervention was envisioned to help in addressing the gaps which arose from the implementation of the Mandanas-Garcia Supreme Court ruling.

For this purpose, the Office of the Undersecretary Margaux Marie V. Salcedo (OUMMVS) aims to proceed with the foundational development of the program for the LGUs. It aims to cascade the expected behavior, attitude, skills and knowledge of a PFM practitioner in the LGUs given the devolution of functions.

The procurement of the training equipment shall support the activities of the OUMMVS in the initial implementation of the PFMCP-LGU.

The schedule of procurement of the following items is in August 2023.
