

**CONTRACT FOR THE CONSULTANCY SERVICES

KNOW ALL MEN BY THIS PRESENTS:

This Contract is executed and entered into by and between the following:

The **DEPARTMENT OF BUDGET AND MANAGEMENT** ("the First Party"), a government institution created under Executive Order No. 25, as amended, and operating under Executive Order No. 292, with principal address at the Boncodin Hall, General Solano St., San Miguel, Manila, herein represented by **Secretary FLORENCIO B. ABAD**;

-and-

Ms. CHARISSE-FUSCHIA A. PADERNA ("the Second Party") of legal age, Filipino, with residence address at Unit 606 Princeville Condominium, Laurel St., Pleasant Hills, Mandaluyong City;

WITNESSETH

WHEREAS, on August 12, 2013, the First Party entered into a contract for consultancy services with the Second Party as Issues and Media Manager at the Office of Secretary-Public Information Unit, for a period of six (6) months, i.e. from August 15, 2013 to February 15, 2014;

WHEREAS, upon the recommendation of Undersecretary Clare Cattleya G. Amador and with approval from Secretary Florencio B. Abad, the above-cited contract was renewed four times in succession to extend the Second Party's services until May 15, 2015;

WHEREAS, Undersecretary Cattleya G. Amador requested further renewal of the services of the Second Party for a period of six (6) months, i.e. from May 16 to November 15, 2015, in accordance with Section 53.7 of the Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, the Original Contract dated August 12, 2013 shall be amended to broaden the services and scope of work of the Second Party;

WHEREAS, the Second Party's services and scope of work shall accommodate the Secretary's speechwriting and presentation development requirements, a function previously assigned to the Strategic Communications Unit under the Strategic Communication Consultant;

WHEREAS, the Second Party's services and scope of work shall also involve ensuring that all projects, task and responsibilities under the Public Information Unit (PIU) are duly fulfilled and/or accomplished within their set timeframes, and involve representing the PIU in events, meetings, or fora where discussion on the DBM's communication initiatives are relevant;

WHEREAS, the Second Party's performance securities posted on August 1, 2013 and on _____ shall serve as her performance securities for the period May 16 to November 15, 2015;

NOW, THEREFORE, for and in consideration of the above premises and the covenant hereafter stipulated, the parties hereby agree as follows:

2. The amount payable to the Second Party shall be increased from not more than Fifty-Five Thousand Pesos (P55,000.00) per month to not more than Sixty-Five Thousand Pesos (P65,000.00) per month, inclusive of all the Second Party's costs, including per diems and profits, as well as any tax obligation that may be imposed on the Second Party.

3. All other provisions of the Original Contract dated August 12, 2013 not in conflict with this contract remains operative and in full force and effect. The instant contract including those previously executed constitutes the entire agreement between both parties.


