BAC Resolution Declaring Single Calculated and Responsive Bid, and Recommending Award of Contract for the "Lease of Venue with Hotel Accommodation and Catering Services for thirty (30) persons"

RESOLUTION No. 2022-05-017

WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to three (3) bonafide local suppliers namely: QUEST HOTEL AND CONFERENCE CENTER CEBU, PACIFIC CEBU RESORT, and ALENTER RESORT HOTELS for the "Lease of Venue with Hotel Accommodation and Catering Services for thirty (30) persons" thru Negotiated-Lease of Real Property and Venue with a total Approved Budget for the Contract (ABC) of ₱150,000.00;

WHEREAS, the RFQs were duly acknowledged and received by the above suppliers;

WHEREAS, in response to the said request, ONLY QUEST HOTEL AND CONFERENCE CENTER CEBU has submitted their quotations within the deadline of bid submission;

WHEREAS, the quotation received was evaluated by the Committee on a "per lot" basis with a passing rate of 90%. The bidders were evaluated using the criteria on Table D - Table of Rating Factors for Lease of Venue, pages 184-185, Annex H of the 2016 Revised IRR of RA 9184, with emphasis on (a) Availability, (b) Location & Site Condition, (c) Neighborhood Data, and (4) Venue, wherein QUEST HOTEL AND CONFERENCE CENTER CEBU attained a rating of 97.87%;

WHEREAS, upon careful examination of the quoted/bid, QUEST HOTEL AND CONFERENCE CENTER CEBU was found to have offered the Single Calculated and Responsive Bid, as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a.) To declare QUEST HOTEL AND CONFERENCE CENTER CEBU as the bidder with the Single Calculated and Responsive Bid and Recommend award of contract to the said supplier with a total contract price of \$\mathbb{P}150,000.00;
- b.) To specify in the **Notice of Award (NOA)** that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- c.) To recommend for approval by the <u>REGIONAL DIRECTOR</u> of the <u>DEPARTMENT OF BUDGET AND MANAGEMENT ROVIII</u> the foregoing findings and recommendation.
