## BAC Resolution Declaring Lowest Calculated and Responsive Bid, and Recommending Award of Contract for the "Supply and Delivery of Safe, Purified Drinking Water and Water Dispenser from January to December 2023"

WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to three (3) bonafide local suppliers namely: CRYSTAL CLEAR, SMART WATER REFILLING STATION , and GS WATER STATION for the "Supply and Delivery of Safe, Purified Drinking Water and Water Dispenser from January to December 2023" thru Negotiated-Small Value Procurement with a total Approved Budget for the Contract (ABC) of ₱28,000.00;

WHEREAS, the RFQs were duly acknowledged and received by the above suppliers;

WHEREAS, in response to the said request, ALL have submitted their quotation within the deadline of bid submission;

WHEREAS, the quotation received was evaluated by the Committee on a "per lot" basis;

WHEREAS, upon careful examination of the quoted/bid, CRYSTAL CLEAR was found to have offered the Lowest Calculated and Responsive Bid, as indicated in the attached Abstract of Quotation;

**NOW, THEREFORE,** We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a.) To declare CRYSTAL CLEAR as the bidder with the Lowest Calculated and Responsive Bid for the Supply and Delivery of Safe, Purified Drinking Water and Water Dispenser from January to December 2023 and Recommend award of contract to the said supplier with a total contract price of ₱28,000.00;
- b.) To specify in the **Notice of Award (NOA)** that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- c.) To recommend for approval by the <u>**REGIONAL DIRECTOR</u>** of the <u>**DEPARTMENT OF BUDGET**</u> <u>**AND MANAGEMENT ROVIII**</u> the foregoing findings and recommendation.</u>
