BAC Resolution Declaring Lowest Calculated and Responsive Bid, and Recommending Award of Contract for the "Lease of Venue with Catering Services for the Conduct of Gender and Development Year-End Assessment cum Year-End Gathering"

WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to five (5) bonafide local suppliers namely: HOTEL ALEJANDRO, SUMMIT HOTEL, MADISON HOTEL, THE ORIENTAL HOTEL, and HOTEL COSTA BRAVA for the "Lease of Venue with Catering Services for the Conduct of Gender and Development Year-End Assessment cum Year-End Gathering" thru Negotiated-Lease of Real Property and Venue with a total Approved Budget for the Contract (ABC) of ₱134,477.00;

WHEREAS, the RFQs were duly acknowledged and received by the above suppliers;

WHEREAS, in response to the said request, ALL have submitted their quotation within the deadline of bid submission;

WHEREA\$, the quotations received were evaluated by the Committee on a "per lot" basis;

WHEREAS, upon careful examination of the quoted/bid, HOTEL ALEJANDRO was found to have offered the Lowest Calculated and Responsive Bid, as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a.) To declare HOTEL ALEJANDRO as the bidder with the Lowest Calculated and Responsive Bid for the Lease of Venue with Catering Services for the Conduct of Gender and Development Year-End Assessment cum Year-End Gathering and Recommend award of contract to the said supplier with a total contract price of \$\mathbb{P}133,250.00;
- b.) To specify in the **Notice of Award (NOA)** that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- c.) To recommend for approval by the <u>REGIONAL DIRECTOR</u> of the <u>DEPARTMENT OF BUDGET AND MANAGEMENT ROVIII</u> the foregoing findings and recommendation.
