BAC Resolution Declaring Lowest Calculated and Responsive Bid, and Recommending Award of Contract for the "Supply and Delivery of Desktop Computers"

## RESOLUTION No. 2022-03-007

WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to five (5) bonafide local suppliers namely: GREENWARE, JOEBZ, EDS, OCTAGON, AND SAM-SKY OFFICE AND SCHOOL SUPPLIES for the "Supply and Delivery of Desktop Computers" thru Shopping 52.1(b) with a total Approved Budget for the Contract (ABC) of P241,944.00;

WHEREAS, the RFQs were duly acknowledged and received by the above suppliers;

WHEREAS, in response to the said request, ALL have submitted their quotations within the deadline of bid submission;

**WHEREAS,** pursuant to BAC Resolution No. 2020-09-022, the bid evaluation was conducted by the BAC in person and virtually via Google Meet;

WHEREAS, the quotations received were evaluated by the Committee on a "per lot" basis;

WHEREAS, upon careful examination of the quoted/bid, SAM-SKY OFFICE AND SCHOOL SUPPLIES was found to have offered the Lowest Calculated and Responsive Bid, as indicated in the attached Abstract of Quotation;

**NOW, THEREFORE,** We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a.) To declare SAM-SKY OFFICE AND SCHOOL SUPPLIES as the bidder with the Lowest Calculated and Responsive Bid for the "Supply and Delivery of Desktop Computers" and Recommend award of contract to the said supplier with a total contract price of P210,000.00;
- b.) To specify in the **Notice of Award (NOA)** that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- c.) To recommend for approval by the <u>REGIONAL DIRECTOR</u> of the <u>DEPARTMENT OF</u> <u>BUDGET AND MANAGEMENT ROVIII</u> the foregoing findings and recommendation.
