This RENEWAL OF CONTRACT made and entered into by and between the following:

DEPARTMENT OF BUDGET AND MANAGEMENT MIMAROPA REGIONAL OFFICE, a government agency created by virtue of the laws of the Republic of the Philippines, with principal office address at 2nd Floor CSP Building 815 Quezon Avenue, Barangay Sta. Cruz, Quezon City, represented herein by its DIRECTOR IV, MR. RICKY L. SANCHEZ, hereinafter called the "CLIENT";

- and -

CAPABLE WARRIOR SECURITY & INVESTIGATION SERVICES INC., a corporation duly organized and existing under the laws of the Republic of the Philippines, with office address at, GF, 2217 Natividad Building, Zapote Road, Brgy 178, Camarin, Caloocan City, represented by its AUTHORIZED REPRESENTATIVE, MR. RICARDO M. ARMOREDA, hereinafter referred to as the "AGENCY";

Collectively, the "PARTIES."

WITNESSETH:

WHEREAS, the PARTIES entered into a Security Services Agreement which was in force and effect from January 1, 2023 until December 31, 2023. A copy of the said Original Contract is herein attached as "ANNEX A" and made an integral part of this Agreement;

WHEREAS, the renewal of the Security Services Agreement is necessary for the continued protection and safety of the CLIENT facilities, equipment and employees. The period of renewal is from January 1, 2024 to December 31, 2024;

WHEREAS, the Guidelines on the Renewal of Regular and Recurring Services¹ provides that the procuring entities may renew the contract not to exceed one (1) year, provided it complies with the conditions stated therein;

WHEREAS, the Head of the Procuring Entity (HoPE) approved the Bids and Award Committee (BAC) Resolution No. 2023-014 recommending the renewal of the contract for Security Services from January 1, 2024 to December 31, 2024, with a total contract amount of One Million One Hundred Fifteen Thousand Two Hundred Twenty-Eight Pesos and 51/100 (P1,115,228.51)

NOW, THEREFORE, the PARTIES hereby agree as follows:

 The terms and conditions of the Original Contracts shall be read and construed as part of this Agreement, and all terms and conditions of the Original Contract which are not inconsistent with this Agreement shall remain unchanged and in full force and effect.

- The PARTIES agree to renew the Original Contract for an additional period which shall begin immediately upon the expiration of the Original Contract, or from January 1, 2024 until December 31, 2024.
- 3. Should there be any wage or mandated benefit increase in favor of the assigned security personnel subsequent to the execution of the Contract pursuant to a Law, Executive Order, Decree or Wage Order, the AGENCY must inform the CLIENT in writing of the wage increase to allow the latter to undertake the appropriate measures to address the same before its implementation, subject to the accounting and auditing rules and regulations and upon showing actual payment made to their employees.
