## RENEWAL OF CONTRACT

### Supply and Delivery of Purified Drinking Water

This RENEWAL OF CONTRACT made and entered into by and between the following:

**DEPARTMENT OF BUDGET AND MANAGEMENT MIMAROPA REGIONAL OFFICE**, a government agency created by virtue of the laws of the Republic of the Philippines, with principal office address at 2<sup>nd</sup> Floor CSP Building 815 Quezon Avenue, Barangay Sta. Cruz, Quezon City, represented herein by **its DIRECTOR IV, MR. RICKY L. SANCHEZ**, hereinafter called the "**CLIENT**";

**H2O PLUS WATER TREATMENT CO**, a company duly organized and existing under the laws of the Philippines, with principal office located at 4004 Gen T. De Leon, Valenzuela City represented herein by **MS. JANE L. TIU**, hereinafter referred to as the "**SUPPLIER**".

#### WITNESSETH:

**WHEREAS**, the PARTIES entered into a Contract/ Purchase Order which was in force and effect from January 1, 2023 until December 31, 2023. A copy of the said Original Contract/ Purchase Order is herein attached as "ANNEX A" and made an integral part of this Agreement;

**WHEREAS**, the Guidelines on the Renewal of Regular and Recurring Services<sup>1</sup> provides that the procuring entities may renew the contract not to exceed one (1) year, provided it complies with the conditions stated therein;

**WHEREAS**, the Head of the Procuring Entity (HoPE) approved the Bids and Award Committee (BAC) Resolution No. 2023-014 recommending the renewal of the contract for the Supply and Delivery of Purified Drinking Water from January 1, 2024 to December 31, 2024, with a total contract amount of Twenty-Three Thousand Seven Hundred Twelve Pesos (P23,712.00);

**NOW, THEREFORE**, the PARTIES hereby agree as follows:

1. The terms and conditions of the Original Contract/Purchase Order shall be read and construed as part of this Agreement, and all terms and conditions of the Original Contract that are not inconsistent with this Agreement shall remain unchanged and in full force and effect.
2. The PARTIES agree to renew the Original Contract/Purchase Order for an additional period which shall begin immediately upon the expiration of the Original Contract/ Purchase Order, or from January 1, 2024, until December 31, 2024.
