**BAC Resolution Declaring Single Calculated and Responsive Bid and
Recommending Award of Contract for the project
“Delivery of Security Services (Lot 1)”**

WHEREAS, the Department of Budget and Management ROVIII thru its Bids and Awards Committee (BAC) has conducted procurement activities for the project “Delivery of Security and Janitorial Services” with a total ABC of ₱1,435,737 thru competitive public bidding having two (2) lots, to wit:

WHEREAS, one (1) supplier for Lot 1 purchased the bid documents while two (2) suppliers for Lot 2; and subsequently said suppliers submitted their respective bid within the deadline of submission on December 1, 2023, namely, for Lot 1: Vision Security Services Inc., and for Lot 2: Vision Janitorial and Allied Services and A & B Multi Serv Corporation;

WHEREAS, the bid of the lone supplier for Lot 1, Vision Security Services, Inc., was declared by the BAC as the Single Calculated Bid subject to post qualification process, while for Lot2, the same was declared failure per BAC Resolution No. 2023-11-040;

WHEREAS, results of the post qualification showed Vision Security Services Inc. responsive with the procurement requirements per attached post qualification report;

WHEREAS, the subject procurement project is undertaken through Early Procurement Activities (EPA), hence, the award of contract to the Lowest/Single Calculated and Responsive Bid may only be made by the Procuring Entity upon approval or enactment of the FY 2024 General Appropriations Act (GAA) pursuant to Section 7.6 of the 2016 Revised IRR of RA 9184 and the provisions under GPPB Circular 06-2019 dated July 17, 2019;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a.) To declare **Vision Security Services Inc.** as the bidder with the **Single Calculated and Responsive Bid** and **Recommend Award of Contract** to the said supplier with a total contract price of **₱835,380.59** for the **“Delivery of Security Services (Lot 1)”** subject to the approval or enactment of the 2024 GAA and the provisions under GPPB Circular 06-2019 dated July 17, 2019, as applicable;
- b.) To recommend for approval by the **REGIONAL DIRECTOR** of the **DEPARTMENT OF BUDGET AND MANAGEMENT ROVIII** the foregoing findings and recommendation.
