**BAC Resolution Declaring Lowest Calculated and Responsive Bid,
and Recommending Award of Contract for the
"Procurement of FY 2024 Courier Services"**

WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to four (4) bonafide local suppliers namely: **SOUTH SEAS CARGO**, **LIBCAP SUPER EXPRESS CORP.**, **2GO EXPRESS INC.**, and **AP CARGO LOGISTICS CORPORATION** for the "Procurement of FY 2024 Courier Services" thru **Negotiated-Small Value Procurement (SVP)** with a total **Approved Budget for the Contract (ABC) of ₱62,480.00**;

WHEREAS, the RFQs were duly acknowledged and received by the above suppliers;

WHEREAS, in response to the said request, ALL have submitted their quotation within the deadline of bid submission except **SOUTH SEAS CARGO** and **AP CARGO LOGISTICS CORPORATION**;

WHEREAS, the quotations received were evaluated by the Committee on a "per lot" basis;

WHEREAS, upon careful examination of the quoted/bid, **LIBCAP SUPER EXPRESS CORP.** was found to have offered the **Lowest Calculated and Responsive Bid**, as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a.) To declare **LIBCAP SUPER EXPRESS CORP.** as the bidder with the **Lowest Calculated and Responsive Bid** for the "**Procurement of FY 2024 Courier Services**" and Recommend award of contract to the said supplier with a total contract price of **₱54,660.00**;
- b.) To specify in the Notice of Award (NOA) that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- c.) To recommend for approval by the **REGIONAL DIRECTOR** of the **DEPARTMENT OF BUDGET AND MANAGEMENT ROVIII** the foregoing findings and recommendation.
