#### Resolution No. 2024-17

**WHEREAS**, the Department of Budget and Management-Bids and Awards Committee (DBM-BAC) conducted a Public Bidding for the Project, "Renewal of MySQL Enterprise Edition Subscription," with an Approved Budget for the Contract of P9,670,000.00 through the authorized appropriations under the FY 2024 General Appropriations Act (GAA), as reflected in the Annual Procurement Plan, CY 2024;

**WHEREAS**, on February 6, 2024, the Invitation to Bid for the Project was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, the DBM website, the official DBM Facebook page, and all DBM bulletin boards;

**WHEREAS**, only one (1) prospective bidder, DBQuest, Inc. (DBQuest), attended the Pre-bid Conference on February 13, 2024;

**WHEREAS**, Supplemental/Bid Bulletin No. 1 was issued on February 20, 2024 to clarify, modify or amend items in the Bidding Documents;

**WHEREAS**, during the submission and opening of bids on February 27, 2024, only one (1) bidder, DBQuest, submitted a bid;

**WHEREAS**, after preliminary examination of the bid, the DBM-BAC, using non-discretionary "pass/fail" criteria, determined the submission of DBQuest as "passed" for complying with all the eligibility and technical requirements as stated in the Bidding Documents;

**WHEREAS**, after evaluation of the financial component of the bid of DBQuest, the DBM-BAC declared the submission of DBQuest as the Single Calculated Bid in the amount of P9,312,786.00;

**WHEREAS**, after verification, validation, and ascertainment of all statements made and documents submitted by DBQuest, using non-discretionary criteria, as stated in the Bidding Documents, it was determined that the submission of DBQuest passed all the criteria for post-qualification;

**WHEREAS**, Section 36 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 provides, among others, that a single calculated and responsive bid shall be considered for award if only one bidder submits a bid, and its bid is found to be responsive to the bidding requirements.

**NOW, THEREFORE**, for and in consideration of the foregoing premises, the DBM-BAC **RESOLVED**, as it is hereby **RESOLVED**, the following:

- 1) To declare the bid of DBQuest, Inc. for the Project, "Renewal of MySQL Enterprise Edition Subscription," in the amount of P9,312,786.00 as the Single Calculated and Responsive Bid, in accordance with Section 34.4 in relation to Section 36 of the 2016 Revised IRR of RA No. 9184; and
- 2) To recommend to the DBM Secretary, as the Head of the Procuring Entity, that the contract for the Project be awarded to DBQuest, Inc. in the above-mentioned amount, in accordance with Section 37.1.1 of the same IRR.
