This SBB No. 1 dated June 6, 2023 for **Project No. DBM-2023-23**, "**Procurement of Motor Vehicles for the Exercise of Executive Functions**," is issued pursuant to Section 22.5 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, to clarify, modify or amend items in the Bidding Documents. Accordingly, this shall form an integral part of the Bidding Documents.

Queries:

1. Specific budget per item -

Based on your Invitation to Bid, the total Approved Budget for the Contract is at Twelve Million Three Hundred Fifteen Thousand Pesos (P12,315,000.00). This project is consisting of two items, indicated in Annex A-Detailed Technical Specifications.

May I please clarify as to how much is the breakdown of budget for Item 3.1 (Six [6] Units of Multi-Purpose Vehicle [MPV]) and Item 3.2 (Three [3] Units of MPV).

2. Warranty Retention –

Our dealership, Toyota Balintawak, Inc., could provide a Warranty retention in the form of a Bank Guarantee with one (1) year validity only, because as per bank policy, they can only issue bank guarantee validity of 360 days because credit limits are being renewed on a yearly basis. However, please rest assured that the warranty of "Three (3) years or 100,000 Kilometers, whichever comes first" shall stand as a solid commitment by our manufacturer, Toyota Motor Philippines (TMP), as indicated on our Warranty Booklet can be availed nationwide.

May I please be clarified on this matter to avoid delay on payment, as based on past experiences, the procuring agency does not release full payment as they require a Bank Guarantee with 3-year validity.

3. May I also clarify how many copies to submit aside from the originals.

Clarifications:

1. Please refer to Clause 1 of Section II. Instructions to Bidders wherein it partially states that "The Procurement Project (referred to herein as "Project") is composed of one (1) lot, the details of which are described in Section VII (Technical Specifications)." Thus, there is no breakdown as to the ABC since the project is bidded as one (1) lot.

2. Based on Section 62.1 of the Revised IRR of RA No. 9184, a warranty security in the form of retention money or special bank guarantee is required to ensure that the all the conditions of the imposed under the contract have been fully met. The warranty security shall only be released after the lapse of the warranty period. The required percentage for said warranty security is specified in the said Section.

Please refer to Clause 5.1 of Section V. Special Conditions of the Contract reflected in this SBB for the details of the warranty security.

3. As stated in Clause 15 of Section II. Instructions to Bidders, only one copy of the first and second components of the Bid is required to be submitted.

Other matters:

- ➤ The "No Contact Rule" shall be strictly observed. Bidders are not allowed to communicate with any member of the Bids and Awards Committee, Technical Working Group or Secretariat effective June 13, 2023 right after the opening of bids.
