NATIONAL GOVERNMENT DISBURSEMENT PERFORMANCE AS OF OCTOBER 2020

National Government spending for the month of October 2020 amounted to P289.6 billion, slightly lower by 6.8 percent when compared to the P310.8 billion outturn for the same month last year. The decline is attributed mainly to the lower infrastructure and other capital outlays amid the impact of COVID-19 pandemic on the implementation of various capital outlay projects this year. Nonetheless, the ten-month cumulative disbursements have reached P3,312.2 billion, expanding significantly by P374.5 billion or 12.7 percent year-on-year owing largely to the government's COVID-19 measures.




Figure 1. National Government Disbursements for the Period Indicated

For the month of October 2020, NCA expenditures amounted to P258.0 billion, down by P19.7 billion or 7.1 percent year-on-year, as mentioned, mainly due to lower infrastructure spending. Similarly, Non-NCA disbursements decreased by P1.6 billion or 4.7 percent from a year ago to reach P31.6 billion. Year-to-date, NCA disbursements totaled P2,834.4 billion, up by P386.6 billion or 15.8 percent year-on-year, while Non-NCA disbursements amounted to P477.8 billion, down by P12.1 billion or 2.5 percent from the comparable period last year.

As of end-October 2020, allotment releases totaled to P4,155.1 billion, exceeding the P4,100.0 billion obligation program for the year by P55.1 billion resulting from the various releases from other special appropriations law (e.g., *Bayanihan* I and II), Continuing Appropriations, other Automatic Appropriations, and Unprogrammed Appropriations mainly to support the government's response towards the COVID-19 emergency. Meanwhile, releases for the month of October 2020 amounted to P83.6 billion¹, consisted largely of the *Bayanihan* II (RA No. 11494) allotments as follows:

Year-on-Year Performance, by Expense Class

For the Month of October 2020

Disbursements for the month of October 2020 amounted to P289.6 billion, P21.2 billion or 6.8 percent less than the previous year's level on account of the following expenditure outturns:

 Infrastructure and other capital outlays amounted to P57.1 billion, down by P25.1 billion or 30.6 percent. Although an increase was recorded in the disbursements for capital outlay (CO) projects of the Department of National Defense (DND) under the Revised Armed Forces of the Philippines (AFP) Modernization Program, it only tempered the

decline in infrastructure spending of the Department of Public Works and Highways (DPWH) and the Department of Transportation (DOTr). As noted earlier, the implementation of some government infrastructure projects has been hindered by various delays, especially during the imposition of community quarantine measures in the earlier part of the year to contain the further spread of the COVID-19 virus.

 Maintenance and other operating expenditures for the month of October closed at P55.3 billion, lower by P6.0 billion or 9.9 percent from a year ago. This is mainly accounted by the decline in the disbursements of the Commission on Higher Education (CHED) pending payments for the Free Higher Education (FHE) and Tertiary Education Subsidy (TES) Programs following the adjusted schedule of the opening of classes for this academic year. Nonetheless, increases were noted in the Department of Social Welfare and Development (DSWD) resulting from the continuing implementation of the Social Amelioration Program II (SAP) and other protection services programs, and in the case of the Department of Health (DOH) for the payment of salaries and benefits of employees hired under emergency hiring of health personnel² in response to the COVID-19 health emergency.

 Personnel services expenditures amounted to P80.6 billion, down by P2.7 billion or 3.3 percent year-on-year owing to the one-off expense for the pension differential³ of military and uniformed personnel (MUP) which was released in October 2019.

The decline in disbursements for the period, however, was partially offset by the increase in the combined allotment and capital transfers to LGUs (P47.7 billion and P19.3 billion), which expanded by P13.2 billion or 24.4 percent year-on-year to reach P67.0 billion. This was the result of higher IRA of LGUs from the proceeds of internal revenue collections; the annual block grant to the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) pursuant to R.A No. 11054 or the Bangsamoro Organic Law; and releases for the *Conditional Matching Grant for Road and Bridge Rehabilitation and Improvement* under the Local Government Support Fund (LGSF).

For the Period January to October 2020

For the period under review, NG disbursements totaled to P3,312.2 billion, surging by P374.5 billion or 12.7 percent from last year's comparable period. Spending grew mainly on account of higher maintenance spending and subsidy support to government corporations for the COVID-19 measures under R.A. No. 11469 or the *Bayanihan* to Heal as One Act (*Bayanihan* I). Allotment and capital transfers to LGUs also increased as a result of the one-time COVID-19 *Bayanihan* Grant to the Provinces, Cities, and Municipalities, higher internal revenue shares of LGUs, and the releases for the annual block grant to the BARMM.

The recorded growth for the said expense items, however, was moderated by lower infrastructure and other capital outlays, and net lending. Infrastructure spending was lower year-on-year (18.4 percent) to P508.5 billion owing mainly to the delays encountered in the implementation of public works and the discontinuance of some projects due to the COVID-19 pandemic. Meanwhile, net lending was down to minus P24.7 billion from P17.1 billion for same period last year. This is largely due to the conversion of NG advances into subsidy where previous net lending releases are treated as subsidy and at the same time recorded as repayments.

Outlook for the Rest of the Year

Based on the preliminary report of allotment releases covering November 1 to 30, 2020⁴, some P154.2 billion worth of allotments have been issued, which included the following big-ticket releases:

Meanwhile, in terms of the *Bayanihan* II, releases have already reached P96.4 billion as of November 30, 2020.⁵ These are expected to push the NG disbursements close, if not attain the full year target, and narrow the recorded spending gap of P246.2 billion or 7.2 percent of the program for the period January to September 2020. This is especially true since, historically, spending tends to accelerate in the latter part of November to December as line agencies try to complete their programs and projects and settle payables before the year ends.

With the fiscal year 2020 about to conclude with just two months remaining, the implementation of the programs/measures under the *Bayanihan* II by the concerned implementing departments/agencies/corporations becomes more crucial to provide the much-needed government assistance to the public and other sectors greatly affected by the pandemic, restore public confidence, and aid in the country's overall economic recovery.
