No. 1177 and to other pertinent laws, to augment any other item in the appropriation for the Office of the Special Prosecutor; for the maintenance and improvement of the library including the purchase of books and periodicals; and for commutable, reimbursable transportation and representation allowances and fringe benefits for the personnel of the Special Prosecutor as may be approved pursuant to P.D. No. 985.

2. **Appropriations for Specific Activities and Purposes.** The amounts herein appropriated for the functions of the agency shall be used specifically for the following activities and purposes in the indicated amounts and conditions:
