Special Provisions

1. Release of the Fund. The amounts herein-above appropriated shall be released only when the revenue collections exceed revenue targets submitted by the President of the Philippines to Congress pursuant to Section 22, Article VII of the Constitution or when the corresponding funding

or receipts for the purpose have been realized: PROVIDED, That in cases of foreign-assisted projects, the existence of a perfected loan or grant agreement shall be sufficient compliance for the issuance of an Advice of Allotment covering the loan or grant proceeds: PROVIDED, FURTHER, That no amount of the Unprogrammed Fund shall be funded out of the savings generated from programmed items in this Act.

2. Support to National Power Corporation. The amount of One Billion Pesos (P1,000,000,000) from the accumulated unexpended balance of the Special Account in the General Fund created under Section 8 of P.D. No. 910, as amended by P. D. No. 1234, is hereby made available as equity investment in the National Power Corporation in support of its projects for power generation, transmission and distribution, including system and utility operational facilities, to be implemented/released upon approval of the President.

3. Release of Funds for the Nationwide (By District) Socialized Housing Program. Of the amount herein appropriated, Four Hundred Million Pesos (P400,000,000) shall be allocated for low-cost housing projects and One Hundred Million Pesos (P100,000,000) for the purchase of land through the Land Bank of the Philippines for resettlement, which shall be implemented by the National Housing Authority after prior consultation with, and endorsement by, the respective representatives of the legislative districts.

4. Use/Charging of Income. The utilization of income from insurance proceeds, auction sales and income authorized by law to be used for specific purposes shall be charged against the unprogrammed General Fund Adjustments.
