**Special Provisions**

1. Use and Release of Fund. The amount herein appropriated shall be used for infrastructure, purchase of equipment and other priority projects and activities, including current operating expenditures, except creation of new plantilla positions, as proposed and identified by officials concerned according to the following allocations: Representatives, Twelve Million Five Hundred Thousand Pesos (P12,500,000) each; Senators, Eighteen Million Pesos ( P18,000,000) each; Vice-President, Twenty Million Pesos (P20,000,000).

The Fund shall be released semi-annually by way of Special Allotment Release Order and Notice of Cash Allocation directly to the designated implementing agency not later than thirty (30) days after the beginning of each semester upon submission of the list of projects and activities by the officials concerned.

2. Submission of Semi-Annual Reports. The Department of Budget and Management shall submit within thirty (30) days after the end of each semester a report to the Senate Committee on Finance and the House Committee on Appropriations on the releases made from this fund. The report shall include the listing of the projects, locations, implementing agencies and the endorsing officials.
