Special Provisions

- 1. Release of the Fund. The amounts herein appropriated shall be released only sinen the revenue collections exceed the original revenue targets submitted by the President of the Philippines to Congress pursuant to Section 22, Article VII of the Constitution or when the corresponding funding or receipts for the purpose have been realized except in the special cases covered by specific procedures in Special Provision Nos. 2, 3, 4, 6, and 14 herein: PROVIDED, That in cases of foreign-assisted projects, the existence of a perfected loan agreement shall be sufficient compliance for the issuance of a Special Allotment Release Order covering the loan proceeds: PROVIDED, FURTHER, That no amount of the Unprogrammed Fund shall be funded out of the savings generated from programmed items in this Act.
- 2. Stock Dividends. In case of declaration of stock dividends by government-owned and/or controlled corporations in favor of the Mational Government pursuant to R.A. No. 7656, this shall be considered as equity contributions of the Mational Government to said corporations subject to approval by the President: PROVIDED, That such contributions shall be chargeable against Purpose 1 Budgetary Support to Government-Owned and/or Controlled Corporations: PROVIDED, FURTHER, That such contributions shall require only the issuance of Special Allotment Release Order for book entry purposes.
- 3. Offsets Against Budgetary Support to Government Corporations. The interest on National Government advances either for principal or interest made by the Bureau of the Treasury for loan obligations of NEA and NHA as approved pursuant to Joint Circular (DBM, DOF and GCMCC) 1-88 dated 20 July 1988 shall be converted into subsidy or equity of the National Government as the case may be. Such conversion shall require the issuance of Special Allotment Release Order for book entry purposes chargeable against Purpose I Budgetary Support to Government-Owned and/or Controlled Corporations.
- 4. Conversion of Liabilities of the Lung Center of the Philippines into Mational Government Subsidy. The appropriation authorized in Purpose I Budgetary Support to Government-Owned and/or Controlled Corporations may be used to cover the conversion into subsidy to Lung Center of the Philippines of the Mational Government advances including interest thereon made by the Bureau of the Treasury as of December 31, 1998 for loan obligations of the Philippine Charity Sweepstakes Office which was authorized by the Office of the President to be transferred to the Lung Center of the Philippines. Such conversion shall require only the issuance of Special Allotment Release Order for book entry purposes.

5. Relending to Local Government Units. The amount appropriated under the Municipal Development Fund shall be used for releading to LGUs and shall be released to and administered by the Bureau of Local Government Finance of the Department of Finance for the following foreign-loan assisted projects, in consultation with the representative of the legislative district concerned:

- 6. Shares from Proceeds of Lotto Operations of the Philippine Charity Sweepstakes Office. The Commission on Higher Education (CHED) and the Philippine Crop Insurance Corporation (PCIC) shall be entitled to their shares from the lotto operations, subject to the certification of the receipt of funds from the Philippine Charity Sweepstakes Office (PCSD) by the Bureau of the Treasury as follows:
- a. CHED. One percent (1%) of gross sales of the PCSO from its lotto operations pursuant to Section 10 of R.A. No. 7722, for the Higher Education Development Fund;
 - b. PCIC. Ten percent (10%) of the net earnings of the PCSO from its lotto operations, pursuant to Section 6 of R.A. No. 8175.
- c. Above funds shall be released by the Department of Budget and Management (DBM) upon submission by the CHED and the PCIC of the list of specific programs and projects to be funded therefrom, copy furnished the House Committee on Appropriations and the Senate Committee on Finance. Subsequent releases will be authorized by the DBM upon submission of the accomplishment report on the implementation of the programs and projects funded therein: PROVIDED, That further releases shall be made only upon submission of the said requirement.
- 7. Agricultural Competitiveness Enhancement Fund. The Appropriations herein authorized shall be funded from the accumulated proceeds of duties collected from 1996, 1997, and 1998 from the importation of agricultural products within the minimum access volume commitment to MTO in accordance with R.A. No. 8178: PROVIDED, That the same shall be a continuing fund and shall be used to finance irrigation, farm-to-market roads, post-harvest equipment and facilities, credit, research and development, other marketing infrastructure, provision of market information, retraining, extension services, and other forms of assistance and support to the agricultural sector mandated under Section 8 of R.A. No. 8178. This shall be a special fund with the National Treasury and specific projects shall be identified by Congress.
- 8. Authorized Overdrafts of Departments/Agencies. The amount appropriated under Purpose 5 General Fund Adjustments may be used to cover past authorized overdrafts of bureaus/agencies pertaining to salary increase, bonus, terminal leave, retirement gratuity, and outstanding claims against the OPSF pursuant to section 21 of R.A. No. 8479, the Downstream Oil Industry Deregulation Act of 1998, as mandated by existing circulars issued for the purpose: PROVIDED, That such overdrafts shall be validated by the Commission on Audit: PROVIDED, FURTHER, That such appropriation shall require only the issuance of a Special Allotment Release Order for book entry purposes.
- 9. Specific Local Government Shares. Such amount as may be necessary under Purpose 5- General Fund Adjustments may be used to cover remittances of the shares in national revenue of concerned LGUs affected by the declaration and establishment of special economic zones pursuant to R. A. No. 7227 and R.A. No. 7916 and the shares of LGUs from Value-Added Tax collections pursuant to R.A. No. 7643, upon submittal by concerned LGU of a Special Budget request duly supported by a certification of actual collections made by the Bureau of Internal Revenue and certification of the Bureau of the Treasury that the receipts collected for the purpose have actually been remitted to the National Treasury: PROVIDED, That the shares from Value-Added Tax shall be allocated in accordance with Section 150 of R.A. No. 7160, the Local Government Code of 1991.
- 10. Road Right-Of-May (ROM) for BOT Projects. The amount herein appropriated under Purpose 5 General Fund Adjustments shall be used for road right-of-may requirements for BOT projects whenever the BOT agreement concerned so requires, subject to the submission of a Special Budget pursuant to Section 35, Chapter 5, Book VI of E.O. Mo. 292: PROVIDED, That such request shall be supported by a certification showing that the collections representing concession fees due and accruing to the Toll Regulatory Board have been actually collected and remitted by the Philippine Mational Construction Corporation to the Mational Treasury.
- 11. Modernization of the PNP, NAPOLCOM and MANRIA. The funds needed to support the modernization program of Philippine National Police, National Police Commission and Mational Mapping and Resource Information Authority shall, among others, be sourced and augmented from the proceeds of privatization as well as disposition of the assets of the said agencies other than those specified in R.A. Mo. 7227, as amended by R.A. No. 7917. The funds thus generated shall be automatically appropriated up to the extent necessary for the purpose, subject to Section 35, Chapter 5, Book VI of E.O. No. 292. Any proceeds in excess of actual funding requirements shall be reverted to the General Fund.
- 12. Partido Development Administration. The amount necessary to support the operating expenses such as personnel costs and maintenance and other operating expenses of the Partido Development Administration (PDA) shall be funded from the special fund under Section 12 of P.D. No. 1869, as amended, pursuant to Section 6 of the Partido Development Administration Act of 1995 (R.A. No. 7820): PROVIDED, That the appropriation to cover such amount shall be charged against Purpose 5 General Fund Adjustments: PROVIDED, FURTHER, That the amount shall be released directly to the PDA, through the Bureau of the Treasury, subject to the submission of a special budget pursuant to Section 35, Chapter 5, Book VI of E.O. No. 292.
- 13. Use of Income from Fees and Charges. Agencies collecting fees and charges as shown in the 1999 Budget of Expenditures and Sources of Financing for services rendered are authorized to use during the Calendar Year Fifty Percent (50%) of the actual increase in collections from such fees and charges between 1997 and 1998 chargeable against Purpose 5 General Fund Adjustments, to augment their

respective current appropriations: PROVIDED, That the use of said increase in collections shall be subject to the submission of a special budget pursuant to Section 35, Chapter 5, Book VI of E.O. No. 292: PROVIDED, FURTHER, That said increase shall not be used to augment Personal Services appropriations.

14. Use/Charging of Income. Departments and agencies which are listed hereunder are authorized to use their income chargeable against Purpose 5 - General Fund Adjustments, subject to the limitations indicated herein and to special budgets pursuant to Section 35, Chapter 5, Book VI of E.O. No. 292, except as otherwise provided hereunder: PROVIDED, That such income shall have been actually collected and remitted to the National Treasury: PROVIDED, FURTHER, That such income shall not be used for the creation of positions nor for payment of salaries, wages or allowances of existing permanent positions: PROVIDED, FURTHERMORE, That if the authority to use income herein granted is availed of by the Agency, it is precluded from availing itself of the use of income under Special Provision No. 13 hereof: PROVIDED, FINALLY, That the department or agency concerned shall submit to the Department of Budget and Management a quarterly report of such income and its utilization, and in case of failure to submit said requirement, no withdramal shall be allowed in subsequent quarters except upon certification of the DBM that said requirement was submitted.
