Special Provision

1. Use and Release of Fund. The amount herein appropriated for the Lingap Para sa Mahihirap Program Fund shall be used exclusively to satisfy the minimum basic needs of poor communities and disadvantaged sectors: PROVIDED, That such amount shall be released directly to the implementing agency upon prior consultation with the Members of Congress concerned.

2. Socialized Housing Program. The amount appropriated for socialized housing program shall be used as follows:

a. Two Hundred Fifty Million Pesos (P250,000,000) as government contribution for capitalization of joint venture for the construction of low-cost and socialized housing in all regions except the National Capital Region (NCR). Allocation of funds per region shall be pro-rata to the urban population of the region.

b. Two Hundred Fifty Million Pesos (P250,000,000) for the acquisition of sites and payment of services in highly urbanized communities in all regions except the National Capital Region (NCR). Allocation of funds per region shall be pro-rata to the urban population of the region.
