#### MEMORANDUM CIRCULAR NO. 09

DIRECTING ALL GOVERNMENT AGENCIES AND INSTRUMENTALITIES, INCLUDING GOVERNMENT-OWNED OR -CONTROLLED CORPORATIONS, AND ENCOURAGING LOCAL GOVERNMENT UNITS, TO EXTEND SUPPORT TO THE 2016 FEDERATION INTERNATIONALE DE VOLLEYBALL WOMEN'S CLUB WORLD CHAMPIONSHIP

WHEREAS, the Philippine Super Liga (PSL) will host the 2016 Federation Internationale de Volleyball (FIVB) Women's Club World Championship (WCWC) to be held on 18 to 23 October 2016 in Metro Manila; and

**WHEREAS**, this will be an opportunity for the further recognition of the Philippines as a world-class venue for international sporting events.
