THE HONORABLE SPEAKER LADIES AND GENTLEMEN OF THE HOUSE OF REPRESENTATIVES

By the power vested in me by the 1987 Constitution, I hereby sign into law Republic Act (RA) No. <u>12116</u>, the General Appropriations Act (GAA) for Fiscal Year (FY) 2025, entitled -

AN ACT APPROPRIATING FUNDS FOR THE OPERATION OF THE GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES FROM JANUARY ONE TO DECEMBER THIRTY-ONE, TWO THOUSAND AND TWENTY-FIVE.

Building on the progress of the previous two years, the National Budget is anchored on the three pillars of the Philippine Development Plan (PDP) 2023-2028:

Develop and Protect the Capabilities of Individuals and Families, including initiatives to promote human and social development, reduce vulnerabilities and protect purchasing power, and increase the income-earning ability of Filipinos;

Transform Production Sectors to Generate More Quality Jobs and Competitive Products by modernizing agriculture and agri-business, revitalizing industry, reinvigorating services, and advancing research and development, technology, and innovation; and

Create an Enabling Environment by strengthening good governance, improving bureaucratic efficiency, ensuring peace and security, enhancing the administration of justice, expanding and upgrading infrastructure, ensuring macroeconomic stability, expanding inclusive and innovative finance, accelerating climate action, and strengthening disaster resilience.



I. GENERAL COMMENTS

The total programmed appropriations for FY 2025 amounts to Php 6.326 trillion, equivalent to 22.0 percent of gross domestic product (GDP) and higher by 9.7 percent compared to FY 2024.

Strong capital formation accompanied by accelerated government spending will continue to be pursued, with infrastructure spending strategically maintained at 5.0 to 6.0 percent of GDP to sustain a high growth trajectory. This will have a multiplier effect on the economy, improve the ease of doing business, and facilitate the creation of more jobs. It will also support efforts to modernize agriculture and agribusinesses, promote trade and investments, reinvigorate services, and advance research and development.

Towards meeting our Sustainable Development Goals, we have scaled up sustainable and green investments aligned with the National Climate Change Action Plan (NCCAP) 2011-2028, ensuring that the National Budget is not only growth-enhancing but also disaster-responsive and climate-resilient.

Prudent debt management will be observed to bolster the high-rating affirmations from different global credit rating agencies that will enable us to borrow at lower costs, providing more fiscal space to support infrastructure development and other growth-enhancing programs and projects.

Fiscal discipline will be enforced to ensure the optimal utilization of this Budget to achieve our Agenda for Prosperity despite limitations.

II. DIRECT VETO

As I have emphasized in my Budget Message accompanying the FY 2025 National Expenditure Program (NEP), the aim of this Administration in our Medium-Term Fiscal Program is to ensure that government targets will respond more directly to the needs of the Filipino people as strategic growth-enhancing fiscal consolidation is pursued. We must be clearly driven by this goal because much as we want to do everything we wish for our people immediately and all at the same time, our finite resources compel us to exercise sound judgment to ensure our fiscal sustainability – we must not compromise our future, thus, the imperative need to program our priorities.

It is in this light that I am duty bound to veto certain items of appropriation which are not consistent with our programmed priorities.



A. PROGRAMS/PROJECTS OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS

The programs, projects, and activities that we have programmed in the FY 2025 NEP under the budget of the Department of Public Works and Highways (DPWH) are consistent with the *Build Better More* infrastructure program of our government, and were carefully considered taking into account urgency of need, implementation-readiness, and agency absorptive capacity. In this regard, the items of appropriation under the DPWH which are not consistent with the foregoing, as listed in Annex A hereof, in the total amount of P26,065,700,000.00, are hereby vetoed and marked accordingly in the **Details of DPWH's Programs/Projects, Volume I-C of the FY 2025 GAA**.

B. UNPROGRAMMED APPROPRIATIONS

Unprogrammed Appropriations (UA) serve as standby authority to incur additional agency obligations for priority programs and projects, subject to the existence of revenue sources which are yet to be realized. It is to be noted, however, that expenditures should generally be within the parameters of programmed resources as envisioned by our fiscal planners. Hence, the inclusion of the UA and its purposes in the FY 2025 NEP was the result of meticulous consideration of the priorities and the agencies' capacity for implementation, balanced with the judicious programming of existing and anticipated resources.

Guided by this, I veto the items of appropriation under the UA listed in Annex B hereof and marked accordingly in **Volume I-B** of this Act, in the total amount of P168,240,648,000.00. Relatedly, I veto **UA**, **Special Provision No. 8**, "**Rice Competitiveness Enhancement Fund," Volume I-B**, page 724, considering the veto of the item of appropriation pertaining thereto.

III. CONDITIONAL IMPLEMENTATION

The prudent stewardship of public funds is a mere rhetoric if the same is not translated into effective and responsive public services. Hence, it is the shared fiscal responsibility of the whole government to ensure that the people's funds are utilized in accordance with their authorized purposes, and that the programs, projects, and activities are implemented in compliance with laws, policies, rules, and regulations. Accordingly, I am obliged to subject the implementation of certain provisions in this Act to specified conditions, as follows:

A. STRICT ADHERENCE TO LAWS, POLICIES, RULES, AND REGULATIONS

1. Implementation of National Programs

Per Department of Social Welfare and Development (DSWD)-Office of the Secretary (OSEC), Special Provision No. 3, "Ayuda sa Kapos ang Kita

Lan

Program (AKAP)," Volume I-B, page 230, the AKAP intends to address the significant strain posed by the rising inflation on the financial capacity of those who earn less than minimum wage. However, to ensure that the government assistance is not merely a provisional solution to a persistent issue, I am compelled to subject the implementation thereof to the convergence of efforts of the DSWD, Department of Labor and Employment (DOLE), and National Economic and Development Authority (NEDA), geared towards more strategic interventions leading to the long-term improvement of the lives of the qualified beneficiaries, while guarding against misuse, and duplicative and fragmented benefits. In this regard, the implementation of the AKAP shall be in strict compliance with pertinent laws, rules, regulations, and jurisprudence, and in accordance with the guidelines to be issued jointly by the DSWD, DOLE, and NEDA.

Similarly, in order to maintain a cohesive approach to the Philippine peace process, the implementation of **DSWD-OSEC**, **Special Provision No. 8**, "**PAyapa at MAsaganang PamayaNAn Program**," **Volume I-B**, **page 236**, shall be subject to the guidelines to be issued jointly by the DSWD and Office of the Presidential Adviser on Peace, Reconciliation and Unity (OPAPRU). Moreover, in the execution of the Program, the DSWD shall collaborate with the OPAPRU considering its functions under Executive Order (EO) No. 158, s. 2021 (Strengthening the Policy Framework on Peace, Reconciliation and Unity, and Reorganizing the Government's Administrative Structure for the Purpose).

Moreover, in line with the government's ongoing efforts to promote the decentralization of public service delivery, the implementation of infrastructure projects, including the maintenance and repairs thereof, under **DPWH-OSEC**, **Special Provision No. 6**, "Basic Infrastructure Program," Volume I-B, page 2, shall be subject to RA No. 7160 (Local Government Code of 1991), and other pertinent laws, rules, regulations, and guidelines.

2. Foreign-Assisted Projects

As in recent years, the Congress identified specific foreign-assisted projects (FAPs) under UA, Special Provision No. 4, "Support to Foreign-Assisted Projects," Volume I-B, pages 722-723, chargeable against Purpose No. 3. Nevertheless, it must be emphasized that such identification of the specific FAPs shall not limit the authority of the President to contract foreign loans in accordance with Section 20, Article VII of the 1987 Constitution.

3. Payment of Retirement Benefits and Pensions

The payment of the retirement benefits and pensions for the Office of the Ombudsman is governed by the provisions of RA No. 11059 (Retirement Law of the Office of the Ombudsman). Hence, Office of the Ombudsman, Special Provision No. 5, "Payment of Retirement Benefits and Pensions," Volume I-B, page 618, shall be in accordance with Sections 2 and 3 of the said law. This is underscored in Office of the Ombudsman, Special Provision No. 6, "Release

of Payment of Retirement Benefits and Pensions," Volume I-B, page 618, which explicitly stated that the release of payment of retirement benefits and pensions shall be "subject to the computation and conditions prescribed in applicable retirement laws, rules and regulations."

4. Maintenance and Other Operating Expenses

I reaffirm my commitment towards judicial independence and the efficient administration of justice. Therefore, I remain confident that the Supreme Court shall continuously ensure the equitable allocation and immediate release of Maintenance and Other Operating Expenses to its lower courts in the implementation of The Judiciary-Supreme Court of the Philippines and the Lower Courts, Special Provision No. 7, "Maintenance and Other Operating Expenses of the Lower Courts," Volume I-B, page 562.

5. Receipts and Revenues Collected from the Importation of Rice

As I have highlighted in my approval of RA No. 12078 (An Act Amending Republic Act No. 8178 or the Agricultural Tariffication Act, as amended by Republic Act No. 11203), this Administration's thrust is to help sustain the significant impact achieved in enhancing the livelihood of our rice farmers, ensuring food security, and attaining a productive rice industry. In order to provide a seamless transition from the implementation of RA No. 11203 (An Act Liberalizing the Importation, Exportation and Trading of Rice, Lifting for the Purpose the Quantitative Import Restriction on Rice, and For Other Purposes) to RA No. 12078, it is imperative that Department of Agriculture (DA)-OSEC, Special Provision No. 19, "Rice Competitiveness Enhancement Fund," Volume I-A, page 82, and UA, Special Provision No. 9, "Use of Excess Revenue from the Total Annual Tariff Revenue from Rice Importation," Volume I-B, page 724, shall be subject to the guidelines to be issued by the DA, Department of Finance (DOF), and/or other relevant agencies, as the case may be.

6. National Disaster Risk Reduction and Management Fund

To effectively prepare for, reduce or mitigate the risks of, and respond to, disasters and calamities, the judicious utilization of the National Disaster Risk Reduction and Management Fund (NDRRMF) must be ensured taking into account the need for maintaining an optimum balance between the allocation and replenishments of the Quick Response Funds (QRFs), and the provisions for disaster risk reduction and management programs, projects, and activities. Consequently, the implementation of NDRRMF (Calamity Fund), Special Provision No. 1, item (b), "National Disaster Risk Reduction and Management Program," Volume I-B, page 714, shall be subject to the guidelines to be issued by the Office of Civil Defense and Department of Budget and Management (DBM).

7. Rewards and Incentives Fund

The Bureau of Customs (BOC) has been strongly encouraged to improve its revenue collection performance through the creation of a Rewards and Incentives Fund under RA No. 9335 (Attrition Act of 2005). It is noted, however, that DOF-BOC, Special Provision No. 3, "Rewards and Incentives Fund," Volume I-A, page 927, indicated that the grant of rewards and incentives to the officials and employees of the BOC shall cover the excess in its revenue collection targets from prior years. In this regard, it must be clarified that the implementation of this Special Provision shall be in accordance with Section 4 of RA No. 9335 and Section 9 of its Implementing Rules and Regulations.

Further, inasmuch as this Fund is treated as a Special Account in the General Fund which is part of the total expenditure program for the fiscal year, the implementation of this Special Provision shall be subject to judicious programming based on actual collections and utilization of funds.

B. SHARED FISCAL RESPONSIBILITY

Section 29 (1) of Article VI of the 1987 Constitution states that no money shall be paid out of the Treasury except in pursuance of an appropriation made by law, and Section 32, Chapter 5, Book VI of EO No. 292, s. 1987 (Administrative Code of 1987) provides that all moneys appropriated for functions, activities, projects, and programs shall be available solely for the specific purposes for which these are appropriated. Hence, similar to previous years, I am placing Congress of the Philippines, Special Provision No. 6, "Availability of Appropriations and Cash Allocations," Volume I-A, page 15, under conditional implementation to emphasize that the use and disbursements of funds shall be for the specified purposes and within the period of availability as prescribed under the General Provision on Cash Budgeting System in this Act.

IV. GENERAL OBSERVATION

Consistent with the aim of this National Budget to help the Philippines achieve long-term economic and social transformation, I hereby convey my standpoint on the implementation of certain provisions for the guidance of all concerned.

A. ORGANIZATIONAL STRUCTURE

We have always emphasized the importance of complying with salary standardization and compensation laws, rules, and regulations, including policies on the use of appropriations or savings for creating new positions and providing retirement benefits and separation pay. The scrap and build policy in the adjustment and modification of organizational structure, and other existing organization, staffing, compensation, and position classification standards of the

DBM aims to ensure a stable organizational structure across all government agencies. With this, I believe that the Congress will continue to uphold Section 8, Article IX-B of the 1987 Constitution which prohibits the payment of additional compensation, and I trust that the Congress will prudently implement Congress of the Philippines, Special Provision No. 2, "Organizational Structure of the Senate, the House of Representatives, the Senate and House of Representatives Electoral Tribunals and the Commission on Appointments," Volume I-A, page 15.

B. ITEM OF APPROPRIATION

As recognized by the Supreme Court in *Araullo, et al. v. Aquino III, et al.,* G.R. No. 209287 (Resolution), February 3, 2015, "an item of appropriation must be an item characterized by singular correspondence – meaning an allocation of a specified singular amount for a specified singular purpose, otherwise known as a 'line-item.' xxx The item referred to by Section 25(5), [Article VI] of the Constitution is the last and indivisible purpose of a program in the appropriation law." Accordingly, the amount under **DPWH-OSEC**, **Special Provision No. 13**, "**Special Road Fund," Volume I-B, page 3**, should be understood to pertain to the amount under the line item, "Special Road Fund – Motor Vehicle User's Charge (MVUC) as per RA No. 11239."

C. COMPLIANCE WITH THE REQUIREMENTS UNDER EXISTING LAWS, RULES, AND REGULATIONS

As the delivery of quality healthcare services is a major priority of my Administration, I expect that the warehouses to be established under **Department of Health-OSEC**, **Special Provision No. 5**, "Health Facilities Enhancement **Program**," **Volume I-A**, **page 987**, shall be based on utmost necessity and consistent with RA No. 11223 (Universal Health Care Act).

Further, I have always supported the policy that personnel benefits are prioritized in the utilization of savings of the government as authorized in Section 79, General Provisions, "Priority in the Use of Savings," Volume I-B, page 748. However, it must be noted that the "other negotiated benefits" referred to in the same General Provision are not included in the Total Compensation Framework under Congress Joint Resolution No. 4 dated June 17, 2009, as well as other existing compensation laws.

V. IMPLEMENTATION OF NATIONALLY FUNDED PROJECTS IN THE BANGSAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO

The release of funds for the implementation of the nationally funded projects for the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) is understood to be subject to the Supreme Court ruling in the case of *Province of Sulu v. Executive Secretary, et al.*, G.R. Nos. 242255, 243246, and 243693, September 9, 2024. It is to be noted that per Resolution dated November 26, 2024 on the Motions for Partial Reconsideration on the same cases, the Supreme Court expounded that "all decisions, policies and actions taken in reliance on the Province of Sulu's status as part of BARMM during this period shall not be summarily nullified by our ruling. Instead, they shall be addressed in a manner that respects their established impacts on governance, financial allocation, and administrative framework within the Province of Sulu. Appropriate mechanisms must be applied to validate, adapt, or conclude these projects and programs in a way that minimizes potential disruptions to the public interest, maintains stability, and protects the welfare of the people of Sulu."

VI. INCREASES IN APPROPRIATIONS AND NEW BUDGETARY ITEMS

In the exercise of the budget execution function vested upor the Executive Branch, it is understood that the increases in appropriations and new budgetary items introduced by the Congress in this Budget shall be subject to the National Government's cash programming, observance of prudent fiscal management, applicable budget execution rules and procedures, and approval by the President based on the programmed priorities of the government.

Therefore, considering that such increases in appropriations and new budgetary items will have corresponding effects on the outputs and outcomes of the agencies concerned, the DBM shall inform the said agencies of the changes in their respective appropriations and require the submission of their revised performance targets.

VII. CLOSING STATEMENTS

The FY 2025 National Budget is a result of the liberal exercise of the Congress' power of the purse, even as we seek to ensure that the goals set in our PDP 2023-2028 continue to be met amidst our limited fiscal space.

I call on the conscientious utilization of this Budget with the end in mind of sustaining the country's high-growth trajectory and managing inflation while accelerating the implementation of well-targeted social services and structural reforms geared towards achieving our medium-term goals of reducing poverty incidence, decreasing unemployment rates, and achieving upper middle-income status.

While the final version of the National Budget has significant distinctions from the President's proposed Budget, we remain determined to pursue the continued implementation and innovation of reforms in public financial management, procurement, and digitalization through a whole-of-government and a whole-of-society approach for a more efficient and transparent public service.

While we have attained much thus far, we still have a long way to go in achieving a truly inclusive, sustainable and future-proof economy. Inspired by the citizens we serve, let us leverage the FY 2025 National Budget to advance undeterred, focused on the mission to propel our economic and social transformation and meet our goal of a *Bagong Pilipinas* where the needs and aspirations of every Filipino are fulfilled.
