TO : ALL PROVINCIAL GOVERNORS, CITY AND MUNICIPAL MAYORS, MEMBERS OF THE SANGGUNIANG PANLALAWIGAN/PANLUNGSOD/BAYAN, PRESIDENTS OF THE LIGA NG MGA BARANGAY AND FEDERATION OF SANGGUNIANG KABATAAN; DIRECTORS OF THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT, DEPARTMENT OF BUDGET AND MANAGEMENT; AND OTHER OFFICIALS CONCERNED

SUBJECT : **Additional Guidelines on the Payment of Compensation to Ex-Officio Members of the Local Sanggunian**

1.0 PURPOSE

This Circular is issued to provide additional guidelines on the grant of honorarium and benefits to certain ex-officio members of local legislative bodies.

2.0 COVERAGE

All Federation Presidents of the Liga ng mga Barangay and Sangguniang Kabataan (SK) in Municipalities and Cities.

3.0 RULES AND REGULATIONS

In addition to the rules under LBC No. 66 dated March 4, 1998, the following rules shall govern the grant of honorarium and benefits to the President of the Liga ng mga Barangay and SK Federation President:

- 3.1 The grant of honorarium shall be attached to the performance of the regular functions of the positions for which it is intended.
- 3.2 The Punong Barangay and SK Chairman who were elected as federation presidents and therefore sit as ex-officio members in the Sangguniang Bayan may collect honorarium as chairman of the barangay and ex-officio member in the sangguniang barangay at a rate not exceeding P1,000 and P600 per month, respectively,

provided that they continue to perform their functions in the barangay.

- 3.3 In the event that other officials are validly designated to perform the functions of the Punong Barangay and the SK Chairman in the barangay, the designated officials shall be entitled to collect reimbursable travelling and incidental expenses not exceeding P1,000 per month for the representative of the Punong Barangay and P600 for the SK Chairman representative. Said designated officials shall not be entitled to cash gift/christmas bonus.
- 3.4 Funds necessary to pay the reimbursable travelling and incidental expenses of the designated Punong Barangay and SK representatives shall be taken from the funds of the barangay.

4.0 REPEALING CLAUSE

All rules and regulations inconsistent with the provisions of this Circular shall be deemed repealed and modified accordingly.

5.0 EFFECTIVITY

This Circular takes effect immediately.
