TO : ALL PROVINCIAL GOVERNORS, CITY AND MUNICIPAL MAYORS, MEMBERS OF THE SANGGUNIANG PANLALAWIGAN/PANLUNGSOD/BAYAN, PROVINCIAL/CITY/MUNICIPAL TREASURERS, PROVINCIAL/CITY/MUNICIPAL BUDGET OFFICERS, PROVINCIAL AND CITY AUDITORS, REGIONAL DIRECTORS OF THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT AND THE DEPARTMENT OF BUDGET AND MANAGEMENT, AND OTHER OFFICIALS CONCERNED

SUBJECT : GUIDELINES ON THE PAYMENT OF COMPENSATION TO EX-OFFICIO MEMBERS OF THE LOCAL SANGGUNIANG

1.0 PURPOSE

This Circular is being issued to provide for uniform guidelines in the payment of salary and honorarium to ex-officio members of local legislative bodies in accordance with the principles and policy of the Salary Standardization Law under RA 6758, and to implement Administrative Order No. 337 amending Article 77(2) of the Implementing Rules and Regulations of the 1991 Local Government Code (RA 7160).

2.0 COVERAGE

All Federation/Chapter Presidents of the Sangguniang Kabataan (SK) and Liga ng mga Barangay in Municipalities, Cities and Provinces; Municipal and City Federation/Chapter Vice-Presidents of the SK and the Liga ng mga Barangay; and the Presidents of the Provincial Federation of Sangguniang Members of Municipalities and Component Cities.

3.0 RULES AND REGULATIONS


- 3.1 Ex-officio members of local legislative bodies as specified in R.A. No. 7160, shall receive the same compensation benefits as that of their counterpart elective Sanggunian officials.
- 3.2 The ex-officio members in the Sangguniang Panlalawigan representing the SK and the Liga ng mga Barangay shall receive the full amount of their authorized salaries and emoluments from the provincial government where they sit as ex-officio members. The province shall appropriate in full the requirement for the personnel benefits of concerned officials.
- 3.3 The respective Federation/Chapter Vice-Presidents of the Liga ng mga Barangay and SK who sit in the Sangguniang Bayan as ex-officio members in lieu of the Federation/Chapter President who are elevated to the higher Sanggunian, shall collect their full salaries and emoluments from the concerned municipal governments which they represent. The municipality shall provide in full the requirement for the personnel benefits of concerned officials.
- 3.4 The Presidents of the Provincial Federation of Sanggunian Members of municipalities and component cities who sit as ex-officio members in the Sangguniang Panlalawigan shall receive their authorized salary and allowances from the component city or municipality which they represent. The province shall appropriate only the difference in the salary and allowances of said officials such that their total compensation shall be equivalent to the compensation actually being received by their elective counterpart in the Sangguniang Panlalawigan.
- 3.5 As salaried Sangguniang Bayan/Panalalawigan officials, ex-officio members representing the Federation of the SK and the Liga ng mga Barangay shall be allowed to collect the minimum honoraria only as provided under Section 2.5 of LBC 55 (P1,000 or P600 per month as the case may be) from the barangay government which they represent in line with the Constitutional prohibition on the receipt of double compensation in addition to 3.1 above. They shall not be entitled to adjustments that may be authorized in excess of the minimum honoraria provided under RA 7160 as implemented under LBC 63.

4.0 REPEALING CLAUSE

All rules and regulations inconsistent with the provisions of this Circular shall be deemed modified accordingly.

5.0 EFFECTIVITY

This Circular shall take effect immediately.
