BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT TO JUDERO BUILDERS AND SUPPLY FOR THE PROCUREMENT OF THE DBM-ROV PROJECT ENTITLED "CONSTRUCTION OF CARPORT WITH SITE DEVELOPMENT (ACCESS ROAD AND PARKING AREA)

#### RESOLUTION NO. 2019-001

WHEREAS, the Department of Budget and Management, Regional Office V Bids and Awards Committee (BAC) posted on October 9, 2019 in the PhilGEPS Website, the Invitation to Bid for the Construction of the DBM-ROV Carport with Site Development (Access Road and Parking Area) with an Approved Budget for the Contract (ABC) of ₱1,458,000.00 and posted the same in the DBM Website and at a conspicuous place at DBM-ROV for seven (7) calendar days;

WHEREAS, in response to said advertisement, nine (9) contractors purchased the bid documents;

WHEREAS, nine (9) bidders submitted their bids as of October 28, 2019 before 10:00 AM. During the opening of the first envelope, eight (8) bidders were determined eligible. One (1) bidder, VINMOR Construction and Supply, was declared ineligible for not including a Plate Compactor in the List of Contractor's Major Equipment which is one of the equipment required in the implementation of the project;

**WHEREAS**, during the opening of the second envelope containing the financial documents of the eight (8) eligible bidders, the following bids were read as:

**WHEREAS**, upon the conduct of the pass/fail evaluation of the financial eligibility requirements, three (3) out of the eight (8) eligible bidders were declared ineligible or disqualified due to the following reasons:

2.	Golden Tiller Construction & Supply	- Bid Form was in accordance with the prescribed format (ITB Clause 19.1)	
3.	RMA Construction & Supply	<ul> <li>Bid form was not accomplished accordingly (ITB Clause 19.2)</li> </ul>	

**WHEREAS**, based on the Abstract of Bids as calculated, JUDERO Builders and Supply was determined as the Lowest Calculated Bidder (LCB) for the procurement of the project: Construction of Carport with Site Development (Access Road and Parking Area);

WHEREAS, JUDERO Builders and Supply was further subjected to post-qualification;

WHEREAS, after careful examination, verification, validation, and ascertainment of all statements and representations made, including all documents submitted, JUDERO Builders and Supply was determined as the Lowest Calculated and Responsive Bidder and shall be awarded the contract per Section 37.1 of the IRR of RA 9184;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- To declare JUDERO Builders and Supply as the bidder with the Lowest Calculated and Responsive Bid (LCRB) for the Construction of DBM-ROV Carport with Site Development (Access Road and Parking Area);
- b. To recommend award of contract to **JUDERO Builders and Supply** for the above-mentioned project at its total Calculated Bid of ONE MILLION TWO HUNDRED NINETY FOUR THOUSAND ONE HUNDRED FORTY THREE PESOS & 42/100 (₱1,294,143.42);
- c. To recommend for approval to the Head of Procuring Entity (HOPE) of the Department of Budget and Management, RO V the foregoing results.

#### **Contract Agreement**

THIS AGREEMENT, made this 25<sup>th</sup> day of November, 2019 between the **DEPARTMENT OF BUDGET AND MANAGEMENT – REGIONAL OFFICE V**, RAWIS, LEGAZPI CITY, hereinafter called the "Entity" and JUDERO BUILDERS & SUPPLY, SAN FRANCISCO ST. STO. DOMINGO, ALBAY hereinafter called the "Contractor".

WHEREAS, the ENTITY is desirous that the Contractor execute the works for the CONSTRUCTION OF DBM-ROV CARPORT WITH SITE DEVELOPMENT (ACCESS ROAD AND PARKING AREA), hereinafter called "the Works" to be completed within 90 calendar days and the ENTITY has accepted the bid for ONE MILLION TWO HUNDRED NINETY-FOUR THOUSAND ONE HUNDRED FORTY THREE & 42/100 PESOS ONLY (₱ 1,294,143.42) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

  - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (i) Eligibility requirements, documents and/or statements;
  - (j) Performance Security;
  - (k) Notice of Award of Contract and the Bidder's conforme thereto; and
  - (1) Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the **ENTITY** to the **CONTRACTOR** as hereinafter mentioned, the **CONTRACTOR** hereby covenants with the **ENTITY** to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The **ENTITY** hereby covenants to pay the **CONTRACTOR** in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
