### RESOLUTION NO. 2020-05

**A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THE AWARD OF THE CONTRACT TO J.L. BAHIA CONSTRUCTION AND SUPPLY FOR THE PROCUREMENT OF THE PROJECT "CONSTRUCTION OF 9.5 SQ. M DBM-ROV GUARD HOUSE WITH C.R. AND REPAIR AND REHABILITATION OF PORTION OF PERIMETER FENCE 46 M. LONG AND 1.60 M. HIGH"**

**WHEREAS**, the Department of Budget and Management Regional Office V Bids and Awards Committee (BAC) posted on January 31, 2020 in the PhilGEPS Website, the Invitation to Bid for the Construction of 9.5 sq. m. DBM-ROV Guard House with CR, and Repair and Rehabilitation of Portion of Perimeter Fence 46 m. long and 1.60 m. high with an Approved Budget for the Contract (ABC) of P1,450,000.00 and posted the same in the DBM Website and at a conspicuous place at DBM-ROV for seven (7) calendar days;

**WHEREAS**, in response to said advertisement, six (6) prospective bidders purchased the bid documents;

**WHEREAS**, the six (6) bidders submitted their bids on February 24, 2020 before the lapse of deadline for submission of bids at 10:00 AM. During the opening of the first envelope, one (1) bidder, RMA Construction and Supply, was declared ineligible due to the following reasons: expired Mayor's/Business Permit; no pagination observed in the bidding documents submitted; list of minimum equipment required is not provided and only the receipts of the equipment was submitted;

**WHEREAS**, during the preliminary examination of the second envelope containing the financial documents of the five (5) eligible bidders, the following were read as:

5. Raginmund Construction	P1,138,038.80

**WHEREAS**, after the bid evaluation, the following is the ranking of bidders:

3. WCVB Builders	P1,196,282.61
4. Judero Builders and Supply	P1,275,900.05

**WHEREAS**, during the conduct of the Bid Evaluation, it was found out that J.L. Bahia Construction and Supply changed the quantity in the Bill of quantities. A letter was sent seeking for clarification and explanation and his reason was due to typographical error and is willing to implement the required quantity without modifying the bid proposal. With the explanation, the BAC in its deliberation accepted the explanation of J. L. Bahia Construction and Supply to be sufficient. Upon evaluation of the next three (3) lowest bidders, the BAC with the assistance of the TWG found out that they have also committed violations. Savings amounting to P416,173.27 was also considered if the project will be awarded to J. L. Bahia Construction and Supply.

**WHEREAS**, J.L. Bahia Construction and Supply was further subjected to post-qualification by the Technical Working Group;

**WHEREAS**, after careful examination, verification, validation, and ascertainment of all statements and representations made, including all documents submitted, the BAC and TWG determined and recommend the Bid of J.L. Bahia Construction and Supply as the Lowest Calculated and Responsive Bid (LCRB);

**NOW, THEREFORE, We**, the Members of the Bids and Awards Committee, by virtue of the power vested on **US** by law, after duly considering the recommendations in the Post Qualification, hereby RESOLVE as it is hereby RESOLVED to recommend to the HOPE for his consideration and approval, the award of contract for the Construction of 9.5 sq. m. DBM-ROV Guard House with CR, and Repair and Rehabilitation of Portion of Perimeter Fence 46 m. long and 1.60 m. high of DBM-ROV to J.L. Bahia Construction and Supply in the amount of ONE MILLION THIRTY-THREE THOUSAND EIGHT HUNDRED TWENTY-SIX PESOS & 73/100 (P1,033,826.73) ONLY;
