Contract Agreement

THIS AGREEMENT, made this 22nd day of May, 2020 between the **DEPARTMENT OF BUDGET AND MANAGEMENT – REGIONAL OFFICE V**, RAWIS, LEGAZPI CITY, hereinafter called the "Entity" and J. L. BAHIA CONSTRUCTION AND SUPPLY, PUROK 7 REGIDOR ST., BINITAYAN, DARAGA, ALBAY hereinafter called the "Contractor".

WHEREAS, the ENTITY is desirous that the Contractor execute the works for the CONSTRUCTION OF 9.5 SQ. M DBM-ROV GUARD HOUSE WITH CR, AND REPAIR AND REHABILITATION OF PORTION OF PERIMETER FENCE 46 M. LONG AND 1.60 M. HIGH, hereinafter called "the Works" to be completed within 120 calendar days and the ENTITY has accepted the bid for ONE MILLION THIRTY THREE THOUSAND EIGHT HUNDRED TWENTY-SIX PESOS & 73/100 PESOS ONLY (₱1,033,826.73) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents shall be attached, deemed to form, and be read and construed as integral part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Drawings/Plans;
 - (c) Specifications;
 - (d) Invitation to Bid;
 - (e) Instructions to Bidders;
 - (f) Bid Data Sheet:
 - (g) Addenda and/or Supplemental/Bid Bulletins;
 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto; and
 - (1) Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the **ENTITY** to the **CONTRACTOR** as hereinafter mentioned, the **CONTRACTOR** hereby covenants with the **ENTITY** to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The **ENTITY** hereby covenants to pay the **CONTRACTOR** in consideration of the execution and completion of the Works and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
