## **Contract Agreement**

THIS AGREEMENT, made this <u>9th</u> day of March, 2020 between the **DEPARTMENT OF BUDGET AND MANAGEMENT – REGIONAL OFFICE V**, RAWIS, LEGAZPI CITY, hereinafter called the "Entity" and EQUATOR ENERGY CORPORATION of L4 B88 BAYANI ROAD, WESTERN BICUTAN, TAGUIG CITY, 1630 hereinafter called the "Contractor".

WHEREAS, the ENTITY is desirous that the Contractor execute the works for the DESIGN AND BUILD OF 50KW SOLAR POWER SYSTEM OF DBM-ROV, hereinafter called "the Works" to be completed within 180 calendar days and the ENTITY has accepted the bid for FOUR MILLION SIX HUNDRED SEVENTY-FIVE THOUSAND SIXTY-SIX PESOS & 46/100 (P 4,675,066.46) ONLY by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents shall be attached, deemed to form, and be read and construed as integral part of this Agreement, to wit:
  - (a) General and Special Conditions of Contract;
  - (b) Drawings/Plans;
  - (c) Specifications;
  - (d) Approved Bill of Quantities;
  - (e) Invitation to Bid;
  - (f) Instructions to Bidders;
  - (g) Bid Data Sheet;
  - (h) Addenda and/or Supplemental/Bid Bulletins;
  - Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (j) Eligibility requirements, documents and/or statements;
  - (k) Performance Security;

- (1) Notice of Award of Contract and the Bidder's conforme thereto; and
- (m) Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the ENTITY to the CONTRACTOR as hereinafter mentioned, the CONTRACTOR hereby covenants with the ENTITY to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
  - The **ENTITY** hereby covenants to pay the **CONTRACTOR** in consideration of the execution and completion of the Works and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the Contract.
- 5. Warranty Certificates from the Suppliers, Manufacturers, Installers and Contractor, including operating handbook/manual will be delivered to the owner prior to the turn over and acceptance.
- 6. If any disputes or difference of any kind, whatsoever, shall arise between the parties in connection with the implementation of the contract covered, the parties shall make effort to resolve amicably such dispute or difference by mutual consultation.

- 7. Any and for disputes arising from the implementation of the contract covered shall be submitted for Arbitration in the Philippines according to the provision of RA 876, otherwise known as Arbitration law, and RA 9285, otherwise known as Alternative Dispute Resolution Act of 2004. Provided however, that the disputes are within the competence of the Construction Industry Arbitration Commission to resolve it, it shall be referred thereto.
- 8. The contractor is required to perform other protocols/requirements as deemed required by COA, DOLE, and any other government agencies related to infrastructure project.
