

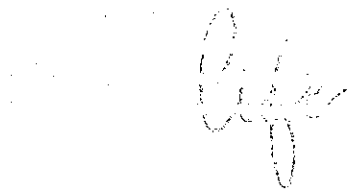

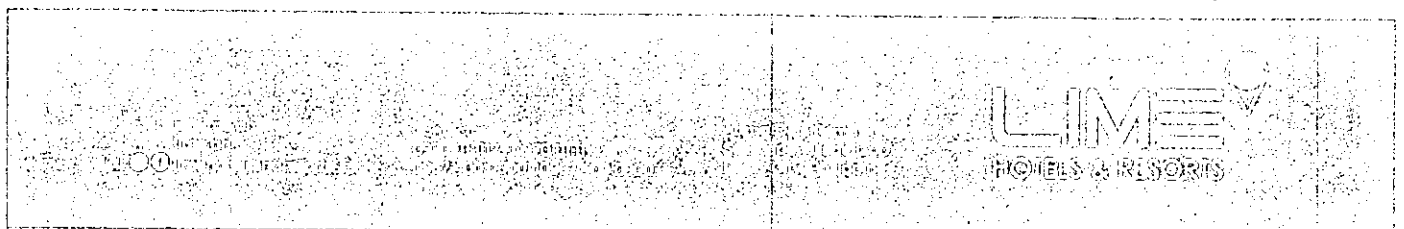

- ✓ If not confirmed within the period given, the bookings will be automatically cancelled, and reinstatement of the reservation is subject to room availability and prevailing room rates.

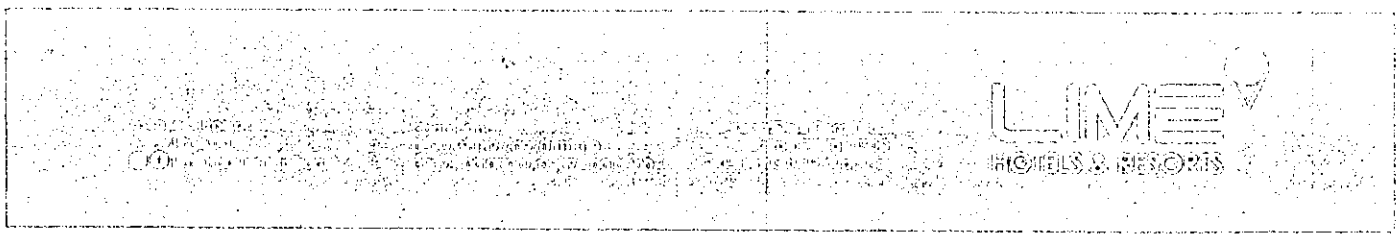
