## Resolution No. 2020-47

**WHEREAS**, the Department of Budget and Management-Bids and Awards Committee (DBM-BAC) conducted a public bidding for the Project, "Replacement of Tiles and Repainting of the Interior Walls and Finishes of Budget Information and Training Service and Budget and Management Bureau-B Offices," which is composed of the following: Lot 1 - Replacement of Tiles and Repainting of the Interior Walls and Finishes of Budget and Management Bureau-B Office, and Lot 2 - Replacement of Tiles and Repainting of the Interior Walls and Finishes of Budget Information and Training Service Office, with Approved Budgets for the Contract of P2,000,000.00 and P1,800,000.00, respectively, with a total of P3,800,000.00, authorized under the FY 2020 General Appropriations Act;

**WHEREAS**, as a background, the Invitation to Bid for the Project was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, the DBM website, and all DBM bulletin boards on August 11, 2020, but a failure of bidding was declared on September 11, 2020 under BAC Resolution No. 2020-43;

**WHEREAS**, on September 29, 2020, the second Invitation to Bid was posted on the PhilGEPS website, the DBM website, and all DBM bulletin boards;

**WHEREAS**, no prospective bidders attended the Pre-bid Conference on October 6, 2020;

**WHEREAS,** Supplemental/Bid Bulletin No. 1 was issued on October 13, 2020 to clarify, modify or amend items in the Bidding Documents;

**WHEREAS**, during the submission and opening of bids on October 20, 2020, two (2) bidders submitted their respective bids for both Lot 1 and Lot 2, namely: (i) Interworld Enterprises (Interworld); and (ii) MMEEN Construction (MMEEN);

**WHEREAS,** after preliminary examination of the bids for Lot 1 and Lot 2, the BAC, using non-discretionary "pass/fail" criteria, determined the following:

1) the submissions of MMEEN for Lot 1 and Lot 2 as "failed" for its failure to submit Section VII. Technical Specifications, as required under Section 25.2 (vii) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, and as stated in Clause 12.1 (b)(ii), Section II. Instructions to Bidders (ITB) of the Bidding Documents; and

2) the submissions of Interworld for Lot 1 and Lot 2 as "failed" for its failure to comply with the requirement for the number of copies of the Bid to be submitted as indicated in ITB Clause 20.3, Section III. Bid Data Sheet of the Bidding Documents;

**WHEREAS**, as stated in Section 30.1 of the 2016 Revised IRR of RA No. 9184, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed."

**NOW, THEREFORE**, for and in consideration of the foregoing premises, the BAC **RESOLVED**, as it hereby **RESOLVED**, the following:

- 1) to declare a second failure of bidding for the Project pursuant to Section 35.1(b) of the 2016 Revised IRR of RA No. 9184; and
- 2) to conduct a re-bidding, and reposting as provided for in Section 21.2 of the same IRR.
