A Resolution Declaring the Lowest Calculated and Responsive Bid
(LCRB)

WHEREAS, the DBM Regional Office I, through its Bids and Awards Committee (BAC), advertised the Invitation to Bid for the Project *Renovation of Staff House, Comfort Rooms, Ceiling and Kitchen* in the PhilGEPS website, DBM website and conspicuous places within its office premises, from August 1-24, 2018;

WHEREAS, in response to the said advertisements, eight (8) bidders logged-in on the PhilGEPS website and two (2) bidders secured a copy of the Bid documents;

WHEREAS, two (2) bids were submitted and opened on August 24, 2018, and both passed the preliminary examination of bids, as follows:

Bidder with the Lowest Calculated Bid – G.O. Marron General Contractor, its bid was found to be non-responsive and post-disqualified;


WHEREAS, the TWG conducted a post-qualification on the second lowest calculated bidder – T.J. Velasco Construction & Supply and found its bid to be responsive and post-qualified;

NOW THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**;


- a. To declare T.J. Velasco Construction & Supply as the Bidder with the Lowest Calculated and Responsive Bid (LCRB) for the Project *Renovation of Staff House, Comfort Rooms, Ceiling and Kitchen* at the DBM RO I, Government Center, Sevilla, City of San Fernando, La Union; and
- b. To recommend the approval of this BAC Resolution by the Director IV of the DBM RO I based on the foregoing findings.
