- 1. The Total Approved Budget for the Contract (ABC) is One Hundred Fifty Five Thousand Three Hundred Pesos only (₱155,300.00).
- 2. Price quotation should be inclusive of tax obligations.
- 3. Evaluation of bids will be conducted on a "per lot" basis.
- 4. Delivery period is **two (2) calendar days** upon receipt of the Notice of Award (NOA) and Purchase Order (PO) at the DBM-Regional Office VIII, Marasbaras, Tacloban City.
