Resolution No. 2018-02

WHEREAS, the Department of Budget and Management-Disposal Committee (DBM-DC) was reconstituted pursuant to Office Order No. 775, dated July 30, 2018 to conduct a public bidding for the disposal of Scrap/Waste Materials "AS Is-Where Is" bases in accordance with COA Circular No. 89-296 dated January 27, 1989;

WHEREAS, on August 02, 2018, the Invitation to Bid for the "Disposal of Scrap/Waste Materials "AS Is-Where Is" bases was advertised in the Philippine Star and posted in the DBM Website, and in all DBM Bulletin Boards;

WHEREAS, on August 07, 2018, a Notice for the change of schedule of the Opening of Bids from August 13, 2018 to August 14, 2018 was posted in the DBM Website and in all DBM Bulletin Boards;

WHEREAS, on August 13, 2018, Fourteen (14) bidders submitted their Bid Proposals for Lot No. 1 and Thirteen (13) for Lot No. 2;

WHEREAS, on August 14, 2018, the Opening of Bids was made in the presence of the DBM-DC, Representatives from Finance Service, Budget Union, DBM-Commission on Audit and interested bidders;

NOW, THEREFORE, for and in consideration of the foregoing premises, the DBM-DC **RESOLVED**, as it hereby **RESOLVES**, to recommend to the DBM Secretary of the issuance of Notice of Award for the disposal of Scrap/Waste Materials to MC JO Trading as the second highest bidder for Lot No. 1.
