Resolution No. 2018- <u>47</u>

WHEREAS, the Department of Budget and Management-Bids and Awards Committee (DBM-BAC) conducted a Negotiated Procurement-Two Failed Biddings for the Project, "eMail Communication Service - Renewal of Licenses for the Subscription of Google Suite Basic," with an Approved Budget for the Contract of P4,362,000.00 for eighteen (18) months;

WHEREAS, on June 27, 2018, an Invitation for Negotiated Procurement-Two Failed Biddings was posted on the Philippine Government Electronic Procurement System website, the DBM website, and all DBM bulletin boards;

WHEREAS, five (5) prospective bidders, namely: (i) Kollab Guru Group Inc.; (ii) SMS Global Technologies Inc.; (iii) Globe Telecom; (iv) ePLDT; and (v) IP Converge Data Services Inc., attended the Meeting with Interested Bidders on July 3, 2018;

WHEREAS, during the submission and opening of the Eligibility, Technical and Financial Documents, and Best and Final Offer on July 13, 2018, two (2) bidders submitted their bids, namely: (i) Kollab Guru Group Inc.; and (ii) IP Converge Data Services Inc.;

WHEREAS, after preliminary examination of the bids, the BAC, using non-discretionary "pass/fail" criteria, determined the following:

- 1. The submission of Kollab Guru Group Inc. as "failed" for its failure to submit a Tax Clearance as required under Clause 12.1(a)(i), Instructions to Bidders of the Bidding Documents and Section 23.1(a)(iii) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184; and
- 2. The submission of IP Converge Data Services Inc. as "passed" for complying with all the eligibility and technical requirements as stated in the Bidding Documents;

WHEREAS, after evaluation of the financial proposal, the BAC declared the submission of IP Converge Data Services Inc. as the Single Calculated Bid in the amount of P4,096,068.00;

WHEREAS, after careful evaluation, validation and verification of the eligibility, technical and financial proposals of the bid, the BAC found that the submission of IP Converge Data Services Inc. passed all the criteria for post-qualification; thus, it was declared as the Single Calculated and Responsive Bid in the amount of P4,096,068.00.

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC **RESOLVED**, as it hereby **RESOLVED**, to recommend to the Secretary of Budget and Management that the contract for the Project, "eMail Communication Service - Renewal of Licenses for the Subscription of Google Suite Basic," be awarded to IP Converge Data Services Inc., in accordance with R.A. No. 9184 and its 2016 Revised IRR.
