WHEREAS, the Department of Budget and Management-Bids and Awards Committee (DBM-BAC) conducted a public bidding for the Project, "Wireless Controller and Access Point Replacement," with an Approved Budget for the Contract of P10,890,000.00, authorized under the FY 2018 General Appropriations Act;

WHEREAS, on November 27, 2018, the Invitation to Bid was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, the DBM website, and all DBM bulletin boards;

WHEREAS, four (4) prospective bidders, namely: (i) Advance Solutions Inc.; (ii) Total Information Management; (iii) PLDT; and (iv) Westcon, responded to the said Invitation and attended the Pre-bid Conference on December 4, 2018;

WHEREAS, Supplemental/Bid Bulletin No. 1 was issued on December 11, 2018 to clarify, modify or amend items in the Bidding Documents;

WHEREAS, during the submission and opening of bids on December 18, 2018, three (3) bidders submitted their bids, namely: (i) Accent Micro Technologies Inc.; (ii) Trends and Technologies Inc.; and (3) Total Information Management;

WHEREAS, after preliminary examination of the bids, the BAC, using non-discretionary "pass/fail" criteria, determined all submissions as "passed" for complying with all the eligibility and technical requirements as stated in the Bidding Documents;

WHEREAS, after evaluation of the financial proposals, the bidders were ranked according to their bid submissions:

Trends and Technologies Inc.

P5,607,500.00;

2. Accent Micro Technologies Inc.

P5,976,353.04; and

3. Total Information Management

P7,502.490.00;

WHEREAS, the BAC declared the submission of Trends and Technologies Inc. as the Lowest Calculated Bid in the amount of P5,607,500.00;

WHEREAS, after careful evaluation, validation and verification of the eligibility, technical and financial proposals of the bid, the BAC found that the submission of Trends and

Technologies Inc. passed all the criteria for post-qualification; thus, it was declared as the Lowest Calculated and Responsive Bid in the amount of P5,607,500.00.

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC **RESOLVED**, as it hereby **RESOLVED**, to recommend to the Secretary of Budget and Management that the contract for the Project, "Wireless Controller and Access Point Replacement," be awarded to Trends and Technologies Inc. in accordance with R.A. No. 9184 and its 2016 Revised IRR.
