Resolution No. 2020-07

WHEREAS, the Department of Budget and Management-Bids and Awards Committee (DBM-BAC) conducted a public bidding for the Project, "DBM Data Center Refresh and Support Services," with an Approved Budget for the Contract of P66,200,000.00;

WHEREAS, under Resolution No. 2019-86 dated December 10, 2019, the BAC declared the first bidding for the Project as "failed" in accordance with Section 35.1(a) of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, on January 7, 2020, the Invitation to Bid was posted on the Philippine Government Electronic Procurement System website, the DBM website, and all DBM bulletin boards;

WHEREAS, six (6) prospective bidders responded to the said Invitation and attended the Pre-Bid Conference on January 14, 2020, namely: (i) Total Information Management Corporation; (ii) SMS Global Technologies; (iii) Multi-fold Links Inc.; (iv) Infobahn Communications Inc.; (v) Maximum Data Infrastructure Technologies Inc.; and (vi) Pronet Systems;

WHEREAS, Supplemental/Bid Bulletin No. 1 was issued on January 21, 2020 to clarify, modify or amend items in the Bidding Documents;

WHEREAS, during the submission and opening of bids on January 28, 2020, only one (1) bidder, Infobahn Communications Inc., submitted a bid;

WHEREAS, after preliminary examination of the bid, the BAC, using non-discretionary "pass/fail" criteria, determined the submission of Infobahn Communications Inc. as "passed" for complying with all the eligibility and technical requirements as stated in the Bidding Documents;

WHEREAS, after evaluation of the financial proposal, the BAC declared the submission of Infobahn Communications Inc. as the Single Calculated Bid in the amount of P65,800,000.00;

WHEREAS, after careful evaluation, validation and verification of the eligibility, technical and financial proposals of the bid, the BAC found that the submission of Infobahn Communications Inc. passed all the criteria for post-qualification; thus, it was declared as the Single Calculated and Responsive Bid in the amount of P65,800,000.00.

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC **RESOLVED**, as it hereby **RESOLVED**, to recommend to the Secretary of the Department of

Budget and Management that the contract for the Project, "DBM Data Center Refresh and Support Services," be awarded to Infobahn Communications Inc., in accordance with Republic Act No. 9184 and its 2016 Revised Implementing Rules and Regulations.

This CONTRACT made and entered into by and between the following:

DEPARTMENT OF BUDGET AND MANAGEMENT, a government agency created by virtue of the laws of the Republic of the Philippines, with principal office address at General Solano St., San Miguel, Manila, represented herein by its **SECRETARY, WENDEL E. AVISADO**, hereinafter called the "**DBM**";

- and -

INFOBAHN COMMUNICATIONS INC., a corporation duly organized and existing under the laws of the Republic of the Philippines, with office address at 2/F Fil-American Bldg., 923 Aurora Blvd. cor. La Salle St., Cubao, Quezon City, represented by **ITS AUTHORIZED REPRESENTATIVE, DEXTER D. DANTES**, hereinafter referred to as the "**SUPPLIER**";

(COLLECTIVELY, THE "PARTIES")

WITNESSETH:

WHEREAS, the DBM conducted a public bidding for the Project, "DBM Data Center Refresh and Support Services," and the bid of the Supplier is in the amount of Sixty Five Million Eight Hundred Thousand Pesos (P65,800,000.00), hereinafter called the "Contract Price";

WHEREAS, pursuant to Sections 37 and 39 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, the Notice of Award was issued to the Supplier last March 3, 2020, and the Supplier posted its performance security in the form of a Performance Bond on March 11, 2020, in the amount of Nineteen Million Seven Hundred Forty Thousand Pesos (P19,740,000.00);


