Resolution No. 2019- 66

WHEREAS, the Department of Budget and Management-Bids and Awards Committee (DBM-BAC) conducted a public bidding for the Project, "Printing and Delivery of Various DBM Publications," with an Approved Budget for the Contract of P1,239,434.00, authorized under the FY 2020 National Expenditure Program;

WHEREAS, on October 22, 2019, an Invitation to Bid was advertised in the Philippine Star, and posted on the Philippine Government Electronic Procurement System website, the DBM website, and all DBM bulletin boards;

WHEREAS, six (6) prospective bidders, namely: (i) Transprint Corporation; (ii) Kayumanggi Press Inc.; (iii) Innovation Printshoppe Inc.; (iv) Cover & Pages Corporation; (v) Velprint Corporation; and (vi) Color1 Digital Inc., responded to the said Invitation and attended the Pre-bid Conference on October 29, 2019;

WHEREAS, Supplemental/Bid Bulletin No. 1 was issued on November 5, 2019 to clarify, modify or amend items in the Bidding Documents;

WHEREAS, during the submission and opening of bids on November 12, 2019, three (3) bidders submitted their bids, namely: (i) Innovation Printshoppe Inc.; (ii) Velprint Corporation; and (iii) Color1 Digital Inc.;

WHEREAS, after preliminary examination of the bids, the BAC, using non-discretionary "pass/fail" criteria, determined the following:

- 1) The submission of Velprint Corporation as "failed" for its failure to pass a patently sufficient Purchase Order; and
- 2) The submissions of Innovation Printshoppe Inc. and Color1 Digital Inc. as "passed" for complying with all the eligibility and technical requirements as stated in the Bidding Documents;

WHEREAS, after evaluation of the financial proposals, the bidders were ranked according to their bid submissions:

1. Color1 Digital Inc.	-	P626,040.00
2. Innovation Printshoppe Inc.	-	P681,400.00

WHEREAS, after careful evaluation, validation and verification of the eligibility, technical and financial proposals of the bid, the BAC found that the submission of Color1 Digital

Inc. passed all the criteria for post-qualification; thus, it was declared as the Lowest Calculated and Responsive Bid in the amount of P626,040.00.

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC **RESOLVED**, as it hereby **RESOLVED**, to recommend to the Secretary of Budget and Management that the contract for the Project, "Printing and Delivery of Various DBM Publications," be awarded to Color1 Digital Inc., in accordance with Republic Act No. 9184 and its 2016 Revised Implementing Rules and Regulations.

PRINTING AND DELIVERY OF VARIOUS DBM PUBLICATIONS

This CONTRACT made and entered into by and between the following:

DEPARTMENT OF BUDGET AND MANAGEMENT, a government agency created by virtue of the laws of the Republic of the Philippines, with principal office address at General Solano St., San Miguel, Manila, represented herein by its Secretary, **WENDEL E. AVISADO**, hereinafter called the "**DBM**";

- and -

COLOR1DIGITAL, INC., a corporation duly organized and existing under the laws of the Republic of the Philippines, with office address at 2321 Marconi Street, San Isidro, Makati City, represented by its duly authorized and designated representative, **SARAH BLANCA DE JESUS**, hereinafter referred to as the "**SUPPLIER**";

WITNESSETH:

WHEREAS, the DBM conducted a public bidding for the Project, "Printing and Delivery of Various DBM Publications," and the bid of the Supplier is in the amount of Six Hundred Twenty Six Thousand Forty Pesos (P626,040.00), hereinafter called the "Contract Price";

WHEREAS, the Notice of Award was issued to the Supplier last January 10, 2020, and the Supplier posted its performance security in the form of a Manager's Check on January 17, 2020, in the amount of P31,302.00;

No agreements, understandings, commitments, discussions, warranty, representations or other covenants, whether oral or written, between the parties are included in this Contract, including the attached Annexes, except as set forth herein.
