**BAC Resolution Declaring Lowest Calculated and Responsive Bid,
and Recommending Award of Contract for the
“Supply, Delivery and Arrangement of Landscaping Materials”**

RESOLUTION No. 2021-11-039

WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotations (RFQ) to six (6) bonafide local suppliers namely, **D’ENVIRONMENT, MEET YOUR GARDEN, CONFLUX BUILDING SPECIFICATION, PING’S GARDEN AND LANDSCAPE, ERIKA MARI GARDEN HUB, and GARDEN’S BY MARICOUR** for the **“Supply, Delivery, and Arrangement of Landscaping Materials”** thru **Negotiated-Small Value Procurement** with a total **Approved Budget for the Contract (ABC) of ₱500,000.00**;

WHEREAS, the RFQs were duly acknowledged and received by the above suppliers;

WHEREAS, in response to the said request, ALL have submitted their quotation within the deadline of bid submission, except for **D’ENVIRONMENT and CONFLUX BUILDING SPECIFICATION**;

WHEREAS, pursuant to BAC Resolution No. 2020-09-022, the bid evaluation was conducted by the BAC in person and virtually via Google Meet;

WHEREAS, the quotations received were evaluated by the Committee on a “per lot” basis;

WHEREAS, upon careful examination of the quoted/bid price, **MEET YOUR GARDEN** was found to have offered the Lowest Calculated and Responsive Bid, as indicated in the attached Abstract of Quotation;


NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


- a.) To declare **MEET YOUR GARDEN** as the bidder with the Lowest Calculated and Responsive Bid for **“Supply, Delivery, and Arrangement of Landscaping Materials”** and Recommend award of contract to the said supplier with a **total contract price of ₱464,800.00**;
- b.) To specify in the **Notice of Award (NOA)** that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- c.) To recommend for approval by the **REGIONAL DIRECTOR** of the **DEPARTMENT OF BUDGET AND MANAGEMENT ROVIII** the foregoing findings and recommendation.


