**BAC Resolution Declaring Single Calculated and Responsive Bid,
and Recommending Award of Contract for the
“Repair and Improvement of COA Office”**

WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to three (3) bonafide local suppliers namely: **MIGHTY A’S CONSTRUCTION, REZSON CONSTRUCTION, and JC BUILDERS AND CONSTRUCTION SUPPLIES** for the “**Repair and Improvement of COA Office**” thru **Negotiated-Small Value Procurement** with a total **Approved Budget for the Contract (ABC) of ₱273,584.00**;

WHEREAS, the RFQs were duly acknowledged and received by the above suppliers;

WHEREAS, in response to the said request, **ONLY REZSON CONSTRUCTION** has submitted its quotation within the deadline of bid submission;

WHEREAS, pursuant to BAC Resolution No. 2020-09-022, the bid evaluation was conducted by the BAC in person and virtually via Google Meet;

WHEREAS, the quotation received was evaluated by the Committee on a “per lot” basis;

WHEREAS, upon careful examination of the quoted/bid, **REZSON CONSTRUCTION** was found to have offered the Single Calculated and Responsive Bid, as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


- a.) To declare **REZSON CONSTRUCTION** as the bidder with the Single Calculated and Responsive Bid for the “**Repair and Improvement of COA Office**” and Recommend award of contract to the said supplier with a total contract price of **₱269,794.00**;
- b.) To specify in the **Notice of Award (NOA)** that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- c.) To recommend for approval by the **REGIONAL DIRECTOR** of the **DEPARTMENT OF BUDGET AND MANAGEMENT ROVIII** the foregoing findings and recommendation.
