**BAC Resolution Declaring Single Calculated and Responsive Bid,
and Recommending Award of Contract for the
“Procurement of Sports Gym and Equipment”**

RESOLUTION No. 2022-03-003

WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotations (RFQ) to four (4) bonafide local suppliers namely, **CUA’S TROPHIES AND ATHLETIC SUPPLY & ENT., EXTREME MUSIC AND SPORTS, TIKOY’S SPORTING GOODS (TOBY’S SPORTS), AND SPORTS BASICS** for the “Procurement of Sports Gym and Equipment” thru **Negotiated-Small Value Procurement** with a total **Approved Budget for the Contract (ABC) of ₱51,000.00**;

WHEREAS, the RFQs were duly acknowledged and received by the above suppliers;

WHEREAS, in response to the said request, only **TIKOY’S SPORTING GOODS (TOBY’S SPORTS)** and **SPORTS BASICS** submitted their quotation within the deadline of bid submission;

WHEREAS, pursuant to BAC Resolution No. 2020-09-022, the bid evaluation was conducted by the BAC in person and virtually via Google Meet;

WHEREAS, the quotations received were evaluated by the Committee on a “per lot” basis;

WHEREAS, upon careful examination of the quoted/bid, **TIKOY’S SPORTING GOODS (TOBY’S SPORTS)** was found to have offered the Single Calculated and Responsive Bid, as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a.) To declare **TIKOY’S SPORTING GOODS (TOBY’S SPORTS)** as the bidder with the Single Calculated and Responsive Bid for the “**Procurement of Sports Gym and Equipment**” and Recommend award of contract to the said supplier with a **total contract price of ₱48,000.00**;
- b.) To specify in the **Notice of Award (NOA)** that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- c.) To recommend for approval by the **REGIONAL DIRECTOR** of the **DEPARTMENT OF BUDGET AND MANAGEMENT ROVIII** the foregoing findings and recommendation.
