**BAC Resolution Declaring Lowest Calculated and Responsive Bid,
and Recommending Award of Contract for the
“Supply and Delivery of Courier Services” for FY 2023**

WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to three (3) bonafide local suppliers namely: **LIBCAP, AP CARGO LOGISTICS, and 2GO EXPRESS** for the “**Supply and Delivery of Courier Services**” for FY 2023 thru **Negotiated-Small Value Procurement** with a total **Approved Budget for the Contract (ABC) of ₱58,760.00**;

WHEREAS, the RFQs were duly acknowledged and received by the above suppliers;

WHEREAS, in response to the said request, only LIBCAP and AP CARGO LOGISTICS have submitted its quotation within the deadline of bid submission;

WHEREAS, the quotation received was evaluated by the Committee on a “per lot” basis;

WHEREAS, upon careful examination of the quoted/bid, **LIBCAP** was found to have offered the Lowest Calculated and Responsive Bid, as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a.) To declare **LIBCAP** as the bidder with the Lowest Calculated and Responsive Bid for the **Supply and Delivery of Courier Services** and Recommend award of contract to the said supplier with a total contract price of **₱58,410.00**;
- b.) To specify in the **Notice of Award (NOA)** that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- c.) To recommend for approval by the **REGIONAL DIRECTOR** of the **DEPARTMENT OF BUDGET AND MANAGEMENT ROVIII** the foregoing findings and recommendation.
