**BAC Resolution Declaring Lowest Calculated and Responsive Bid,
and Recommending Award of Contract for the

WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to five (5) bonafide local suppliers namely: **HOTEL ALEJANDRO, SUMMIT HOTEL, MADISON HOTEL, THE ORIENTAL HOTEL,** and **HOTEL COSTA BRAVA** for the “Lease of Venue with Catering Services for the Conduct of Gender and Development Year-End Assessment cum Year-End Gathering” thru **Negotiated-Lease of Real Property and Venue** with a total **Approved Budget for the Contract (ABC) of ₱134,477.00;**

WHEREAS, in response to the said request, ALL have submitted their quotation within the deadline of bid submission;

WHEREAS, the quotations received were evaluated by the Committee on a “per lot” basis;

- To declare **HOTEL ALEJANDRO** as the bidder with the Lowest Calculated and Responsive Bid for the **Lease of Venue with Catering Services for the Conduct of Gender and Development Year-End Assessment cum Year-End Gathering** and Recommend award of contract to the said supplier with a total contract price of **₱133,250.00;**
- To specify in the **Notice of Award (NOA)** that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- To recommend for approval by the **REGIONAL DIRECTOR** of the **DEPARTMENT OF BUDGET AND MANAGEMENT ROVIII** the foregoing findings and recommendation.
