Resolution No. 2022-55

WHEREAS, the Department of Budget and Management-Bids and Awards Committee (DBM-BAC) conducted a Public Bidding for the Project, "Supply and Delivery of Pins and Rings for the CY 2023 Implementation of DBM's Rewards and Recognition System," with an Approved Budget for the Contract of P1,950,000.00 through the authorized appropriations under the FY 2023 General Appropriations Act (GAA), as reflected in the Indicative Annual Procurement Plan, CY 2023;

WHEREAS, for the purpose of early procurement authorized under Section 7.6 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, the proposed budget under the FY 2023 National Expenditure Program was used as basis;

WHEREAS, on November 22, 2022, the Invitation to Bid for the Project was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, the DBM website, the official DBM Facebook page, and all DBM bulletin boards;

WHEREAS, only one (1) prospective bidder, Laricel's Jewelry, responded to the said Invitation and attended the Pre-bid Conference via videoconferencing on November 29, 2022;

WHEREAS, during the submission and opening of bids on December 13, 2022, only one (1) bidder, Laricel's Jewelry, submitted a bid;

WHEREAS, after preliminary examination of the bid, the DBM-BAC, using non-discretionary "pass/fail" criteria, determined the submission of Laricel's Jewelry as "passed" for complying with all the eligibility and technical requirements as stated in the Bidding Documents;

WHEREAS, after evaluation of the financial component of the bid of Laricel's Jewelry, the DBM-BAC declared the submission of Laricel's Jewelry as the Single Calculated Bid in the amount of P1,909,500.00;

WHEREAS, after verification, validation, and ascertainment of all statements made and documents submitted by Laricel's Jewelry, using non-discretionary criteria, as stated in the Bidding Documents, it was determined that the submission of Laricel's Jewelry passed all the criteria for post-qualification;

WHEREAS, Section 36 of the 2016 Revised IRR of RA No. 9184 provides, among others, that a single calculated and responsive bid shall be considered for award if only one bidder submits a bid, and its bid is found to be responsive to the bidding requirements.

NOW, THEREFORE, for and in consideration of the foregoing premises, the DBM-BAC **RESOLVED**, as it is hereby **RESOLVED**, the following:

- 1) To declare the bid of Laricel's Jewelry for the Project, "Supply and Delivery of Pins and Rings for the CY 2023 Implementation of DBM's Rewards and Recognition System," in the amount of P1,909,500.00 as the Single Calculated and Responsive Bid, in accordance with Section 34.4 in relation to Section 36 of the 2016 Revised IRR of RA No. 9184;
- 2) To recommend to the DBM Secretary, as the Head of the Procuring Entity, that the contract for the Project be awarded to Laricel's Jewelry in the abovementioned amount, in accordance with Section 37.1.1 of the same IRR; and
- 3) To transmit the Notice of Award to the Secretary and issue the same to Laricel's Jewelry upon the effectivity of the FY 2023 GAA, pursuant to Section 7.6 of the 2016 Revised IRR of RA No. 9184.
