WHEREAS, the Department of Budget and Management-Bids and Awards Committee (DBM-BAC) conducted a Public Bidding for the Project, "HP Server Refresh," with an Approved Budget for the Contract of P94,500,000.00 through the authorized appropriations under the FY 2024 General Appropriations Act (GAA), as reflected in the Supplemental Indicative Annual Procurement Plan, CY 2024;

WHEREAS, for the purpose of early procurement authorized under Section 7.6 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, the proposed budget under the FY 2024 National Expenditure Program was used as basis;

WHEREAS, on November 17, 2023, the Invitation to Bid for the Project was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, the DBM website, the official DBM Facebook page, and all DBM bulletin boards;

WHEREAS, six (6) prospective bidders, namely: (i) Questech Co., Inc.; (ii) Integrated Computer Systems, Inc. (ICSI); (iii) Accent Micro Technologies, Inc. (AMTI); (iv) Advance Solutions, Inc. (ASI); (v) Hewlett Packard Enterprise; and (vi) Trends and Technologies, Inc., attended the Pre-bid Conference on November 24, 2023;

WHEREAS, Supplemental/Bid Bulletin No. 1 was issued on December 5, 2023 to clarify, modify or amend items in the Bidding Documents;

WHEREAS, during the submission and opening of bids on December 12, 2023, three (3) bidders submitted their bids, namely: (i) AMTI; (ii) ASI; and (iii) ICSI;

WHEREAS, after preliminary examination of the bids, the DBM-BAC, using nondiscretionary "pass/fail" criteria, determined the submissions of all bidders as "passed" for complying with all the eligibility and technical requirements as stated in the Bidding Documents;

WHEREAS, after evaluation of the financial components of the bids, the bids were ranked based on the total calculated bid prices to identify the Lowest Calculated Bid, as follows:

1.	ICSI	-	P92,089,451.03
2.	ASI	-	P92,148,400.00
3.	AMTI	-	P92,700,000.00

WHEREAS, the DBM-BAC accordingly declared the submission of ICSI as the Lowest Calculated Bid in the amount of P92,089,451.03;

WHEREAS, after verification, validation, and ascertainment of all statements made and documents submitted by ICSI, using non-discretionary criteria, as stated in the Bidding Documents, it was determined that the submission of ICSI passed all the criteria for postqualification.

NOW, THEREFORE, for and in consideration of the foregoing premises, the DBM-BAC **RESOLVED**, as it is hereby **RESOLVED**, the following:

- To declare the bid of Integrated Computer Systems, Inc. for the Project, "HP Server Refresh," in the amount of P92,089,451.03 as the Lowest Calculated and Responsive Bid, in accordance with Section 34.4 of the 2016 Revised IRR of RA No. 9184;
- 2) To recommend to the DBM Secretary, as the Head of the Procuring Entity, that the contract for the Project be awarded to Integrated Computer Systems, Inc. in the above-mentioned amount, in accordance with Section 37.1.1 of the same IRR;
- 3) To notify all other bidders, in writing, of the DBM-BAC's recommendation within three (3) calendar days from the issuance of the resolution recommending award of the contract, pursuant to Section 37.1.1 of the same IRR; and
- 4) To transmit the Notice of Award to the Secretary and issue the same to Integrated Computer Systems, Inc. upon the effectivity of the FY 2024 GAA, pursuant to Section 7.6 of the 2016 Revised IRR of RA No. 9184.

CONTRACT AGREEMENT

THIS AGREEMENT made this _____ day of __**JAN 3 9 2024** 20_____ between the **DEPARTMENT OF BUDGET AND MANAGEMENT** of the Philippines (hereinafter called "the Entity") of the one part and **INTEGRATED COMPUTER SYSTEMS, INC.** of San Juan City, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly HP Server Refresh, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Ninety-Two Million Eighty-Nine Thousand Four Hundred Fifty-One Pesos and 03/100 (P92,089,451.03) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

TECHNICAL SPECIFICATIONS

1. PROJECT TITLE

HP Server Refresh

2. OBJECTIVE

To refresh and modernize the current infrastructure with a next-generation hyperconverged infrastructure platform/system to drive better IT responsiveness, improve operational efficiency and deliver better service. An enterprise-grade Hyper-Convergence Infrastructure system for DBM Application Systems that is compatible with the existing DBM Architecture and designed to provide high-availability (HA), redundancy, data protection and readiness for disaster recovery and automation.

The HP Server Refresh will maintain the performance and functionality of and ensure its compatibility with the existing fleet and equipment. Hence, reference to brand names is authorized under Section 18 of the 2016 Revised IRR of RA 9184 which provides that, "[r]eference to brand names shall not be allowed **except for items or parts that are compatible with the existing fleet of equipment of the same make and brand, and to maintain the performance, functionality and useful life of the equipment"**. (emphasis supplied)

3. DELIVERY PERIOD

The delivery, installation, configuration and operationalization of HP Servers shall be within one hundred twenty (120) calendar days from the receipt of Notice to Proceed (NTP).

4. SCOPE OF WORK

- 4.1 The Hyper-Converge Infrastructure Solution should have the following features but not limited to:
 - 4.1.1 Must be based on a converged IT infrastructure platform that integrates storage, compute, networking, hypervisor, real-time deduplication, compression, and optimization along with powerful data management, data protection, and disaster recovery capabilities in a standard x86 server building block.
 - 4.1.2 Every Hyper-Converge Infrastructure Node must be capable to support the following:
 - 4.1.2.1 Intel Xeon Scalable Processors (Skylake) and DDR4 RAM at 2400 Mhz or above.
 - 4.1.2.2 Minimum of 288 GB of memory supporting up to 1536 GB.
 - 4.1.2.3 Configured all-flash storage with SSD drives a minimum of 1.92 TB per drive.

- 4.1.3 The in-line deduplication and compression shall not put any additional load on the CPU and memory of the node.
- 4.1.4 Must be able to support multiple points of failure with no loss of function or data.
- 4.1.5 Should support stretch cluster deployment in a near-site metro DC.
- 4.1.6 Each node should have a dedicated redundant hot-swappable power supply unit to be able to sustain a single power supply failure.
- 4.1.7 Must be able to sustain the following failures:
 - 4.1.7.1 SDD failure per node without Data Unavailability /Data Loss
 - 4.1.7.2 SDD failures in each node of a cluster and across nodes in the cluster without DU/DL
 - 4.1.7.3 One node failure in the cluster
 - 4.1.7.4 One NIC port failure
- 4.1.8 The hyper-converged solution shall support VM-centric management through a single pane of glass via the virtualization manager of a given hypervisor.
- 4.1.9 Hyper-converge shall have a programmatic interface for enabling automated tasks like failover/failback.
- 4.1.10 Hyper-converge appliance shall have the ability to manage all aspects of the Hyper-convergence for all sites through Virtualization Manager.
- 4.1.11 Hyper-converge shall be able to expose/connect to existing customer servers for hosting VMs and applications while taking advantage of the functionality of the solution.
- 4.1.12 Hyper-converge shall be able to globally manage Backup Policies per Datastore or per VM and shall be able to define the following:
 - 4.1.12.1 How many Backup copied needs to be created locally and globally
 - 4.1.12.2 How much retention is required for a copy locally and globally
- 4.1.13 The hyper-converged solution shall provide the complete flexibility for the following
 - 4.1.13.1 Selecting individual VMs for Backups.
 - 4.1.13.2 Move specific VMs between datacenter.
 - 4.1.13.3 Cloning specific VMs.
 - 4.1.13.4 VM-level backup instead of forcing protection at the datastore or protection domain level.
- 4.1.14 VM Monitoring should have the following features:
 - 4.1.14.1 It must be accessible via a cloud-based dashboard (telemetry data only).
 - 4.1.14.2 Visibility to VM noisy neighbors and insights into VM storage utilization to identify high-consuming VMs and implement corrective actions.
 - 4.1.14.3 Proactive wellness alerts.
 - 4.1.14.4 Historical cluster capacity consumption and prediction to full capacity.
 - 4.1.14.5 System details at the federation, cluster, and node level, plus an "entitlement view," which includes a node's support contract status, a contract expiration notification banner.
- 4.1.15 Data Protection and Recovery
 - 4.1.15.1 Backup functionality shall be an integral feature of Hyper-Converge instead of a separate server/software license.
 - 4.1.15.2 The backup must be an independent copy of source Virtual Server and must allow restoring of deleted/corrupted source Virtual Server

- 4.1.15.3 Must be able to carry simultaneously out bi-directional replication between two data centers.
- 4.1.15.4 Must be able to replicate any-to-any in a Mesh Data Center deployment of more than 3 DC's.
- 4.1.15.5 Must be able to define backup policy per datastore, a group of VMs or specific VM.
- 4.1.15.6 Data Protection should have Recovery Point Objective (RPO) of 10 minutes for local backups.
- 4.1.15.7 Must be able to execute backup tasks during office hours without impact to production workloads.
- 4.1.15.8 Data loss protection against a minimum of 1 simultaneous local hard disk failures in all nodes of the cluster.
- 4.1.15.9 Data loss protection against single node failure in the cluster.
- 4.1.15.10 Must be able to provide backup reports for audit purpose.
- 4.1.15.11 Data recovery should be independent of source Virtual Server.
- 4.1.15.12 The solution should provide a backup catalog to allow any Virtual Server to be recovered to any specific point-in-time.
- 4.1.15.13 The data recovery process should be simple with a Recover Time Objective RTO in a minute.
- 4.1.16 Must be capable of Disaster Recovery with the following features:
 - 4.1.16.1 The solution must provide a simple failover operation.
 - 4.1.16.2 The solution must allow the creation of a Runbook to automate recovery of Virtual Servers.
 - 4.1.16.3 The solution must allow changing of IP address of recovered Virtual Servers to match target datacenter.
 - 4.1.16.4 The solution should allow changing VM settings (e.g. vCPU, vRAM, VMSwitch).
 - 4.1.16.5 The solution must allow the option to test DR failover to separate network with no impact to production workloads.
 - 4.1.16.6 The solution should have a feature to assist in the failback process to Primary datacenter.



2. **OBJECTIVE**

To refresh and modernize the current infrastructure with a next-generation hyperconverged infrastructure platform/system to drive better IT responsiveness, improve operational efficiency and deliver better service. 


