**BAC Resolution Declaring Lowest Calculated and Responsive Bid,
 and Recommending Award of Contract for the
 “Procurement of Catering Services for the Conduct of FY 2024 Mid Year Agency
 Performance Review (APR) Consultation Cum FDU Meeting”**

WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to four (4) bonafide local suppliers namely: **SAL’S BAR AND RESTAURANT, SOPHIA’S WAY EVENTS CENTER, CAFÉ MARGA** and **C PAVILION** for the “Procurement of Catering Services for the Conduct of FY 2024 Mid Year Agency Performance Review (APR) Consultation Cum FDU Meeting” thru Negotiated-Small Value Procurement with a total Approved Budget for the Contract (ABC) of **₱164,550.00**.

WHEREAS, the RFQs were duly acknowledged and received by the above suppliers;

WHEREAS, in response to the said request, **SAL’S BAR AND RESTAURANT, SOPHIA’S WAY EVENTS CENTER**, and **C PAVILION** submitted their quotation within the deadline of bid submission;

WHEREAS, one supplier, **CAFÉ MARGA**, did not submit bid quotation;

WHEREAS, the quotations received were evaluated by the Committee on a “per lot” basis;

WHEREAS, upon careful examination of the quoted/bid, **SOPHIA’S WAY EVENTS CENTER** was found to have offered the Lowest Calculated and Responsive Bid, as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a.) To declare **SOPHIA’S WAY EVENTS CENTER** as the bidder with the Lowest Calculated and Responsive Bid for the “Procurement of Catering Services for the Conduct of FY 2024 Mid Year Agency Performance Review (APR) Consultation Cum FDU Meeting” and Recommend award of contract to the said supplier with a total contract price of **₱163,695.00**;
- b.) To specify in the Notice of Award (NOA) that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- c.) To recommend for approval by the **REGIONAL DIRECTOR** of the **DEPARTMENT OF BUDGET AND MANAGEMENT ROVIII** the foregoing findings and recommendation.
