**BAC Resolution Declaring Lowest Calculated and Responsive Bid,  
and Recommending Award of Contract for the  
"Supply, Delivery, Installation, Commissioning and Testing of Brand New  
Airconditioning Units for CY 2024"**

**RESOLUTION No. 2024-12-069**

**WHEREAS**, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to three (3) bonafide local suppliers namely: **RL APPLIANCE INC., COMPUSPEC SALES AND SERVICES, AND WINTERCRIB AIRCONDITIONING SALES AND SERVICES INC.** thru **Negotiated-Small Value Procurement** with a total **Approved Budget for the Contract (ABC) of ₱429,250.00.**

**WHEREAS**, the RFQs were duly acknowledged and received by the above-mentioned three (3) suppliers;

**WHEREAS**, in response to the said request, only **RL APPLIANCE INC. and COMPUSPEC SALES AND SERVICES** submitted its quotation within the deadline of bid submission; **WINTERCRIB AIRCONDITIONING SALES AND SERVICES INC.** only received the RFQ but did not submit quotation; Moreover, **ICELANDIC AIRE AIRCONDITIONING** hand-carried and submitted its quotation to DBM Regional Office VIII also within the deadline of bid submission;

**WHEREAS**, the quotations received were evaluated by the Committee on a "per lot" basis;

**WHEREAS**, upon careful examination of the quoted/bid, **RL APPLIANCE INC.** was found to have offered the **Lowest Calculated and Responsive Bid**, as indicated in the attached **Abstract of Quotation.**

**NOW, THEREFORE**, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a.) To declare **RL APPLIANCE INC** as the bidder with the **Lowest Calculated and Responsive Bid** for the **"Supply, Delivery, Installation, Commissioning and Testing of Brand New Air-Conditioning Units for CY 2024"** and Recommend award of contract to the said supplier with a total contract price of **₱429,250.00**;
- b.) To specify in the Notice of Award (NOA) that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- c.) To recommend for approval by the **REGIONAL DIRECTOR** of the **DEPARTMENT OF BUDGET AND MANAGEMENT ROVIII** the foregoing findings and recommendation.
