**BAC Resolution Declaring Lowest Calculated and Responsive Bid,
and Recommending Award of Contract for the
“Supply and Delivery of Packed Meals for the Roll-out of Integrated Human Resource
Information System (IHRIS) and Budget Data Analytics Project on September 23 -25,
2024; and 3rd Quarter Nationwide Simultaneous Earthquake Drill (NSED) on
September 26, 2024”**

RESOLUTION No. 2024-09-051

WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to four (4) bonafide local suppliers namely: **SOPHIA’S WAY FOOD CENTER, CAFÉ MARGA, C PAVILION, and HOTEL CONSUELO** for “Supply and Delivery of Packed Meals for the Roll-out of Integrated Human Resource Information System (IHRIS) and Budget Data Analytics Project on September 23 -25, 2024; and 3rd Quarter Nationwide Simultaneous Earthquake Drill (NSED) on September 26, 2024” thru Negotiated-Small Value Procurement with a total **Approved Budget for the Contract (ABC) of ₱67,500.00**.

WHEREAS, the RFQs were duly acknowledged and received by the above mentioned four (4) suppliers;

WHEREAS, in response to the said request, all four (4) suppliers submitted their quotation within the deadline of bid submission;

WHEREAS, the canvasser attempted to issue RFQ to SALS BAR AND RESTAURANT but the supplier did not received the RFQ;

WHEREAS, the quotations received were evaluated by the Committee on a “per lot” basis;

WHEREAS, upon careful examination of the quoted/bid, **CAFÉ MARGA** was found to have offered the Lowest Calculated and Responsive Bid, as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a.) To declare **CAFÉ MARGA** as the bidder with the Lowest Calculated and Responsive Bid for the “**Supply and Delivery of Packed Meals for the Roll-out of Integrated Human Resource Information System (IHRIS) and Budget Data Analytics Project on September 23 -25, 2024; and 3rd Quarter Nationwide Simultaneous Earthquake Drill (NSED) on September 26, 2024**” and Recommend award of contract to the said supplier with a total contract price of **₱66,540.00**;
- b.) To specify in the Notice of Award (NOA) that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and

- c.) To recommend for approval by the REGIONAL DIRECTOR of the DEPARTMENT OF BUDGET AND MANAGEMENT ROVIII the foregoing findings and recommendation.


