**BAC Resolution Declaring Lowest Calculated and Responsive Bid,

**WHEREAS**, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to three (3) bonafide local suppliers namely: **TOPCARS AUTOWORLD CORP, CEBU CAR QUICK FIX CORP, and NICOLAS TIRE AND SERVICE CENTER** for the “**FY 2024 Maintenance of Nissan Urvan (Plate No. OW7909/131201)**” thru **Negotiated-Small Value Procurement** with a total **Approved Budget for the Contract (ABC) of ₱149,090.00**.

**WHEREAS**, the RFQs were duly acknowledged and received by the above suppliers;

**WHEREAS**, in response to the said request, only Topcars Autoworld Corp and Cebu Car Quick Fix Corp has submitted their quotation within the deadline of bid submission;

**WHEREAS**, Nicol<sup>o</sup>s Tire and Service Center did not submit its quotations per information relayed by the canvasser to the BAC;

**WHEREAS**, the quotations received were evaluated by the Committee on a “per lot” basis;

**WHEREAS**, upon careful examination of the quoted/bid, **TOPCARS AUTOWORLD CORP** was found to have offered the **Lowest Calculated and Responsive Bid**, as indicated in the attached Abstract of Quotation;


**NOW, THEREFORE**, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


